Sir,

I, Aparna Roy, D/O Lt. Sridam Roy, R/O Sevoke Road, Samir Roy Sarani, Paresh Nagar, Ward No.- 44, P.O. & P.S. – Bhaktinagar, Dist. – Darjeeling, WB – 734001, would like to lodge a complaint against Manoj Roy, S/O Lt. Sridam Roy and Sanjita Das, W/ O Manoj Roy, Presently residing at Sevoke Road, Samir Roy Sarani, Paresh Nagar, Ward No.- 44, P.O. & P.S. – Bhaktinagar, Dist. – Darjeeling, WB – 734001, stating that I and my Elder Sister Pampa Roy is living with my father at address mentioned above as our husband do not allow us to live in our matrimonial house.

That my brother Manoj Roy and his wife Sanjita Roy do not want us to live in my father's house, therefore they always scold us, torture us mentally and physically. They abuse us and also use abusive language for us in front of whole society. They always threat us. His wife Sanjita Roy use to click my filthy photos and videos many times and threat us that we should leave our father's home.

That On 18.07.2023 at around 7.30 am they broke the door of my room stating my sister as a thief, I am working for our livelihood and for the same reason I come late in the night around 11.30 pm to 12 am, for the same my brother Manoj Roy and his wife Sanjita Roy use different types of filthy languages, they use to speak in front of society that I sleep with another men and working as prostitute.

That on 19.03.2023 at around 03.30 pm they said me and my sister Pampa Roy to leave the house and started conflicts and when I started to defend myself they both started beating me and my brother strangling and kicked in my sister's stomach where she was operated on, so, my sister's stomach started bleeding, after that, I came to protect my sister but my brother and his wife beat her too. Then I felt unconscious but somehow, we reached to District hospital at Siliguri and got treatments.

That they (Manoj Roy and his wife Sanjita Roy) want us to leave our parent house. My father was a cancer patient, needs a well care and treatments, but my brother and his wife did not provide him proper foods neither take him to the doctor for proper treatments and use to beat him many time and due to lack of treatment he is dead now.

That on 13.12.2023, Manoj roy and his wife Sanjit Roy beated me very badly and then Manoj roy used a tin weapon and give a cut on my hand and tear off my clothes.

That we all the legal heirs mutually agreed to devide the rents among us equally but now my brother Manoj roy fights with me and my sister and stops the tenants to pay rent to us, for the same reason on 24. 01.2024, 13.02.2024 and on 14.02.2024 they both husband and wife fought with us, they alway start with abusive language and then beat us. On 13.02.2024 I called the police by dialing 100 and now I am giving this Complaint in writing attaching the order of Ld. Court of CJM at Jalpaiguri dated 18.12.2023 with on photo of my bleeding hand, which cut was given by my blother by a teen weapon.

That they have not stopped behaving cruel to us. Day by day they are showing their more cruel face to us and torture us every day.

Therefore, I request you Sir to be kind enough to arrange to investigate into the matter and take suitable action as soon as possible.
