I, ASI Prasenjit Barman S/O Lt. Sarat Chandra Barman of Ashighar Out Post, Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Gopal Das (36 yrs.) S/O Late Dilip Das of Papiapara Naresh More, PO- Ghoghomali, PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 16/02/2024 at 18:05 hrs. I received source information that above noted arrested accused person is selling liquor in his residence at Papiapara, Naresh More without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar Out Post GDE No 498, Dated 16/02/2024, and shared the information with O/C Ashighar Out Post. Accordingly, as per his kind direction, I along with the officer and force went to Papiapara, Naresh More under Bhaktinagar P.S, Dist. - Jalpaiguri to verify the veracity of the information in hand. On reaching there and as identified by the source we held a raid at the house of the above-noted accused and managed to apprehend him. On being asked he disclosed his identity as noted above and disclosed that he is selling illicit liquor at his residence without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from his residence. On-demand, he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the above-mentioned person namely Gopal Das after observing all sorts of formalities on the spot. The whole process of seizure and label has been made in between 18:40 hrs. to 18:55 hrs.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person namely Gopal Das (36) S/O Lt. Dilip Das of Papiapara, Naresh More, PO- Ghoghomali, PS- Bhaktinagar, Dist.- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
