From the documents provided by TATA Capital Ltd. it appears that the said culprit Mr. Anand Kumar Agarwal is a resident of house number 281, Bellasis road, Vahatuk, Vhavan, Mumbai, Maharashtra, Pin -400008 having email id — anand33203320@gmail.com, who has been using my phone no. and PAN Card details to take loan directly into his account, enjoy the same for which the financial institutions are harassing me unnecessarily.
