Balcharan Roy of Khaikhai Bazaar, Ektiashal, PO- Sevoke Road, PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 23/02/2024 at 16:05 hrs. I received a piece of source information that a person is selling liquor in his roadside Dhaba (without a name) at Khudiram Colony under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No 748, Dated 23/02/2024, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force had been to Khudiram Colony under PS - Bhaktinagar, Dist.- Jalpaiguri to verify the veracity of the information in hand. On reaching there and as identified by the source we held a raid at the roadside dhaba of accused Binoy Roy @ Karan and managed to apprehend him.
