Mr. Mangru Baraik, Sr. TSH, attached with Subhaspally CCC, WBSEDCL, entered into the Domestic premises of Mr. Jagadish Roy, S/O- Late Sushanta Roy, Address: Thakurnagar (near Jaleswari Bazar), P.O. - Sahudangi Hat, PS- Bhaktinagar, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401961333), in order to inspect the service line incoming & leaving the meter as well as Supervisory Checking purpose.

During inspection, the aforesaid accused, Mr. Jagadish Roy, S/O- Late Sushanta Roy, Address: Thakurnagar (near Jaleswari Bazar), P.O. – Sahudangi Hat, PS- Bhaktinagar, District- Jalpaiguri, PIN- 735135 (Consumer ID: 401961333), was found consuming Electricity dishonestly in unauthorized manner by Unauthorized Reconnection of the 'Deemed Disconnected' service connection having Consumer ID: 401961333 & Meter No.: G01889478 which was disconnected on 26.12.2019 due to having outstanding dues of electricity of Rs. 3,820.37 by that time (excluding LPSC). Moreover, the last meter consumption up to which billing was raised is 600 kWh. And, during inspection on 23.02.2024, the service connection was found 'Physically Live' as well as the aforesaid accused person was found consuming electricity through that meter installed in his earmarked Domestic premises for Domestic purposes & the aforesaid energy meter was found 'performing normal' having last reading of 4732 kWh during seizure of the meter.
