Sis,

I, Karabi Roy Ghosh (49) a resident of Priti Apartment, Sebhashpally, Siliguri submitting a written complaint against my husband Raj Kumar Ghosh (50) 810-Akhil Ch. Gope of 27, Green Park, P.O.- Mokdungpur Dist- Malda (Permanent Address) and my in-laws (noted below), all are resident of Malda. This is to inform you that my husband Raj Kumar Ghosh is working as Sr. Adjutant, Home Guard, Kalimpong District in the rank of Inspector of Police.

The fact is, though we knew each other since last three years before marriage and got married on 11.03.2001 at 'Akshay Mangalam Lodge' Malda. After marriage I went to my in-laws house at Green Park, Malda leaving my parents house at Buraburitala, Malda. At the night of Borbhat Ceremony on 13.1.2001 I was totally shocked by seeing my husband

as money hungry, racist and very boastful being
a Sub Inspector (that time) and insulted me by
saying that he deserves a four wheelers but
my father cheated him by not giving even a
motor cycle, and gifted very cheap quality
furnitures & jewellery to their dark skinned
daughter and addressed me by calling in bengali
"Mukhpara Adivasi" and "Beshyar Meye" (daughter
of prostitute). My in-laws namely Jayanti Gope
(22 approx), (sister-in-law), Father-in-law
Akhil Ch. Gope (50) and Mother-in-law Jyotsna Gope
(70) abused me by addressing 'Beshya' (prostitute)
and blamed my parents for giving cheap quality
furniture and jewellery to me. After marriage
ceremony I have returned to my place of
posting at Raiganj, Uttar Dinajpur where I
was posted as Sub-Inspector of Police. After few
months of marriage my husband came to my
residence at Raiganj and forbade me to have any
contact with my parents and addressed my
parents as lower caste (Nama Sudra, Chai Mandal,
Adivasi) and labour class people. On that day
he also taken my jewellery (Stridhan) without
my knowledge and left for his place of posting
at Banskhiauli P.S. and later gave pressure to

me to lodge F.I.R (Theft case) against my parents for stealing those jewelleries which were found at his personel V.I.P suit case at Bamshihari P.S.

Quarrel. He is very misogynistic, as after birth of my daughter in 2004 he behaved very rudely with me for giving birth a girl child. In the year 2005 in between the month of July to September my husband went to CPSL Kolkata for Scientific Investigation training and was involved in an ~~external~~ extramarital affair ~~of~~ with a trainee nurse at Chittaranjan Hospital. Their relationship lasted for a long time as many phone calls came & my husband used to visit her frequently. Over this issue we used to quarrel sometimes, my husband and in-laws (name noted above) even assaulted me physically in the marriage ceremony of my Devas (brothers-in-law) and insulted me & my father by using abusive languages. In the mean time I have been transferred to I.B.N.B.W Siliguri from Udaipur District and found a second hand flat at A.T. Mukherjee Road, Subhashpally Siliguri and showed my willingness to purchase it but my husband ^{expressed} his reluctance to buy it. Then took a loan from SBI, and had withdrawn money from GPF, took some financial help

in cash from my father (ex employee of WBSEBCL) from his retirement benefits and started residing in the said flat from 2011. In 2015, I was detected grade III Breast Cancer in biopsy report and left for Bombay Tata Medical Centre. The treatment ended with four operations, six chemotherapy and twenty radiation therapy and my old parents had to stay with me during the entire treatment period as my husband and in-laws did not show their proper concern for my health.

After return from Bombay my husband and my sister in law behaved rudely with me and my parents making false allegations for cheating them by suppressing the disease of cancer at the time of marriage. From 2016 whenever my parents came to Siliguri from Malda at my flat in every 6 months as I had to visit Tata hospital, Bombay for follow up treatment with old father as attendant, he used to insult my parents that they should be ashamed to eat at their daughter's house free of cost and blamed them for stealing his money and other article. On 20th June 2021, during ^{evening} quarrel my husband became furious and physically assaulted me by kicking in front of my daughter. I got injured and called a police van for help. Next day my

daughter took me to the Doctor Abhishek Agarwal and did X-ray of my waist. My daughter asked me not to tolerate such domestic violence as she also suffered by the backdated & dominating behaviour of her father during her growing up period as my husband does not love girl child. Later I consulted with my lawyer and filed Divorce case in Court on domestic violence ground, vide Matrimonial Suit No. 234/2021, and Misc Case no. 79/2021 Under the protection of women from Domestic Violence Act. After that my daughter moved to the hostel of KIIT University, Bhubaneswar in the month of September, 2022, Since then physical and mental abuse on me exceeded its limit by my husband my husband injured my fingers often to prevent me from learning piano / keyboard. Due to extreme domestic violence by my husband I was compelled to shift in a rented house at Hakimpura. at May 2023. Recently my husband transferred from Siliguri Police Commissionerate and joined Kalimpong District. I have started to reside at my residential flat at Priti Apartment, A.T. Mukherjee Road, Siliguri from 20th February, 2024 because my health condition is poor.

On 24.2.24 at about 18:30 hrs. my husband, came to my residential flat with two unknown person while I am locking the door for going outside. My husband started to make video of mine and instructed both the person to cut the lock of the collapsible which was locked by me. As both the person fix wire and started to cut the lock with gas cutter / electric cutting machine, ^{at 18:50 hrs.} I immediately obstructed, my husband pushed me forcefully and I fell down and got injury on my back. My husband also snatched the gas cutter from cutting Mistro and after receiving obstruction from me to cut the lock my husband made an attempt to kill me by cutting my throat, and asked those unknown person to hold me. To save my life and property I immediately called to T/o Siliguri PS. to send a police van.

I therefore request before you kindly take necessary actions against my husband and in-laws (name noted below) and
