I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 3/4 persons to the effect that on 25.02.24 at 00-15 hrs received a secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place with one Maruti Car at Bhalobasa More under NJP PS with a view to commit dacoity. Accordingly without waste any time I informed the matter to you and duty officer of PS and dirised the matter vide NJP PS GDE No. 1287 dt. 25.02.24 and as per your kind instruction myself alongwith ASI Dhruba Mishra, ASI Khagen Barman, C/769 Aayush Kumar, C/1462 Sajan Tamang, CV-297 Putul Roy, CV-306 Biswajit Roy and also night mobile van ASI Binay Subba and force left from PS for Bhalobasa More to verify the veracity of the information. We reached near the spot as confirmed by the source at about 00-45 hrs and stopped out vehicle at a considerable distance from that place and we started walking towards the said place and we reached near Bhalobasa More found a group of 08/09 persons assemble and gossiping in a dark place at that place under NJP PS and also standing one blue colour Maruti Car at that place. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and they try to flee away with their Maruti Car. Somehow, after a hot chase we could able to apprehend the 05 (five) persons noted above and intercepted the said Maruti Car having No. WB-74-R-1309 and others 3/4 persons managed to flee away from the spot. On interrogation they disclosed their identity and they also stated that they alongwith their other associates assembled there by the said Maruti Car with a view to commit dacoity after making full preparation in the adjacent area of Bhalobasa More under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to
