Sir,

Firstly it was a road rage situation from Gossainpur area when an un-identified vehicle started chasing us and showed us indecent and immoral hand signals to all the females who were present in our vehicle.

I was travelling with Mrs. Uma Roy, Mrs. Ratna Roy and my driver Mr. Jitesh Adhikari. Then he suddenly stopped his car in front of my office vehicle (WB-73-D-6223) and got off from his car and started abusing us. He started yelling his name as Paramartha Saibo and also calims to be police personnel. When we opposed he assaulted me physically, broke my phone on throwing it on the road, and also threw some bottles of alcohol upon our vehicle. When he came closer, I came to know that he is too drunk and was driving himself the vehicle bearing No. WB-36-G-7847 (Mauti-Breeza).

Sir, I am getting ashamed to tell you that he hit me in my leg, hold my neck immorally, torn and unfolded my saree in the middle of the road. When we again asked him to get off from me, he went and came again with a big rock and was about to threw it upon us, but by the grace of God, we got saved. Seeing this, he open his pants zip and peed upon me. I was fully ashamed seeing this and left the place of incident somehow. He drove his car roughly from thereon. My driver drove after him to know his residence, but to our great surprise he resides in my block jurisdiction only. The name of his apartment appears to be "Uttora" in Sarat-Nagar area.

I came to know that he has got two wives viz. Rupa Karjee and Sujata Chetree respectively. His 2nd wife Mrs. Sujata Chetree also came out of the residence and she also started yelling us. Seeing the situation getting worsens and as I was in great physical and metal trauma, we left the site.

Sir, I am in deep mental trauma and physical pain. If I, being Sabhapati of Matigara Panchayat Samitee is . not safe, how I could able to save others of my jurisdiction.

Please consider this letter as an FIR and start legal measures against this Paramartha Saibo person under relevant provisions of Cr. P.C. and IPC.
