I, SI Binup Mahato of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Sukumar Kundu (31yrs) S/O Lt.  Fifteen (15) sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that today 07.03.24 at 17-45 hrs received source information that one person was selling Liquor illegally from his shop named Mama Hotel, Chunabhati More under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith ASI Khagen Barman ASI Dhruba Mishra C/1462 Sajan Tamang, all of NJP PS, SPC left for Chunabhati More to verify the veracity of information vide NJP PS GDE No. 335, Dated- 07.03.24. On arrival at the spot at 18-35 hrs it was found that one person mentioned above was selling liquor illegally from Mama Hotel, Chunabhati More to his designated customers to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally from the his Hotel without any license. Thereafter in presence of witnesses I recovered Fifteen (15) sealed Bottles of Himalayan gold country spirit 60up, each bottle 600 ml from his possession from the said Hotel and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor . As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 18-55 hrs to 19-35 (seizure Total approx 9 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Sukumar Kundu (31yrs) S/O Lt. Subal Chandra Kundu of Purbo Dhantala, Jainagar PS New Jalpaiguri Dist.- Jalpaiguri and arrange for its investigation.
