Subject: Complaint regarding Forceful Entry, Threats, and Theft

Respected Sir,

I, Rajib Das, son of Rabindranath Das, residing at 1st floor, Vasundhara Residency, flat no-2D, Ashrampara, Ward no-14 of S.M.C, P.O & P.S - Siliguri, Dist-Darjeeiing, Pin-734001, am writing this complaint to bring to your attention a distressing incident that occurred on 03/03/2024, Sunday, at my residence.

I got married to Miss Pampa Dutta, daughter of Pradip Kumar Dutta, resident of Shibram Sarani, Laketown, P.S - N.J.P, District - Jalpaiguri, on 17/04/2008, as per Hindu rites and customs. From wedlock of our marriage, our daughter, Purvika Das, was born on 28th February 2013. However, due to certain misunderstandings between us, my wife and I are living separately at present.

On the aforementioned date, my wife, Pampa Dutta, along with her sister's husband namely Mainak Dasgupta, forcefully entered in my flat. They proceeded to threaten me verbally and physically. Suddenly Mainak Dasgupta and my wife hit me on my abdomen and forcibly took away rupees 20,000/- from me. They warned me against reporting the incident to the police or informing anyone else, threatening to harm me further and denying me access to my daughter, Purvika Das if I tell about this incident to anyone.

As a concerned father, I refrained from filing a complaint initially. However, their subsequent threats of implicating me in false criminal cases have compelled me to seek legal intervention. It is pertinent to mention that my wife's sister namely
