In producing herewith (04) four arrested accused persons namely (i) Sujit Roy (36), S/O Tarun Roy of Dabgram, PS. Siliguri, Dist.- Darjeeling (ii) Chris Limbu (22), S/O Late Bipin Limbu of Sandur, PS. Ranipool, Dist. Gangtok, East Sikkim (iii) Anil Sharma (20) S/O Late Uma Sharma of Tandong, PS. Ranipool, Dist. Gangtok, East Sikkim and (iv) Shiva Chhetri (23) S/O Late Suresh Chhetri of Sourini Bazar, PS. Mirik, Dist.- Darjeeling under arrest and the following articles under seizure:-

(i) One iron made weapon locally called as "Bhojali" measuring 18 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Sujit Roy, (ii) one iron made sharp cutting weapon locally called as "Sword" measuring approx 20 inch in length including wooden butt and one sharp cutting knife recovered and seized from the possession of accused Chris Limbu, (iii) One iron made sharp knife and one torch light recovered and seized from the possession of accused Anil Sharma, (iv) One iron made breaking instrument locally called as "Sarashi" measuring 18 inches in length and one torch light recovered and seized from the possession PS, Siliguri Police I, ASI Manoj Kr Roy of Pradhan Nagar of accused Shiva Chhetri. Commissionerate do hereby lodge this written complaint against the above noted 04 (four) arrested accused persons and their 05/06 unknown associates who involve in this crime to the effect that on 18.03.2024 night at 00.15 hrs received a specific source information that about 09/10 persons assembled at Dagapur Play ground, under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoit at Dagapur and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 983 dated 18.03.2024. After getting the permission from you myself accompany with SI Bandhan Roy, ASI Jagannath Roy, C/1411 Ashok Roy, C/1415 Chandan Basak, C/1416 Dilip Barman and C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Dagapur Play ground under Pradhan Nagar PS to verify the veracity of the information. On the way, I informed the matter to RT van officer ASI Mir Saide Alam of Pradhan Nagar PS and directed him to come at Dagapur Play ground to accompany with us for holding raid at Dagapur Play ground. At about 00.30 hrs we reached at Dagapur Play ground, and at around 00.35 hrs night RT van officer ASI Mir Saide Alam along with his RT van force arrived at Dagapur Play ground, and accompanied us. Then I shared the information to all the above noted officers and force and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 09/10 persons assembled in a dark place at Dagapur Play ground and they were whispering in a very low voice. We cordoned the place with due care and caution.

On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted four (04) accused persons with deadly weapons in their possessions while 05/06 others managed to flee away from the spot taking the opportunity of darkness and open place. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Dagapur and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.10 hrs to 01.55 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest, I accordingly brought all the four (04) arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Dagapur and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted four (04) arrested accused persons namely i) Sujit Roy (36), S/O Tarun Roy of Dabgram, PS. Siliguri, Dist.-Darjeeling (ii) Chris Limbu (22), S/O Late Bipin Limbu of Sandur, PS. Ranipool, Dist. Gangtok, East Sikkim (iii) Anil Sharma (20) S/O Late Uma Sharma of Tandong, PS. Ranipool, Dist. Gangtok, East Sikkim and (iv) Shiva Chhetri (23) S/O Late Suresh Chhetri of Sourini Bazar, PS. Mirik, Dist.-Darjeeling and others 05/06 unknown miscreants and arrange for its investigation.
