Sir,

In producing herewith one arrested person namely Goutam Roy (42yrs) S/O Lt Khagendra nath Roy of Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri along with following seized articles wiz..

- 1) Six (6) pieces of 70 UP style as OY OYE each containing 300 ml blended and bottled by Galaxy C.S Bottling plant Nagarkata Jalpaiguri.
- 2) Five (5) pieces of 60 UP Himalayan Gold each containing 600 ml bottled and blended by endeavour PVT Ltd Siliguri.

I, SI Youel Lepcha S/O Jai Tshering Lepcha of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against above noted Goutam Roy (42yrs) S/O Lt Khagendra nath Roy of Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri to the effect that today on 18.03.2024 at 18.45 hrs I received a source information that one person is randomly selling liquor at Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri along, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with ASI Chandra Prakash Adhikary, ASI Dipak Karmakar, C/374 Debraj Biswas all of Bhaktinagar PS had been to Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri along to verify the veracity of the information. This refers to Bhaktinagar PS GDE entry no.876, dated-18.03.2024.

At 19.20hrs we reached there and as identified by the source I found that one person was selling illegal liquor at his house Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri along Subsequently, I along with officers and force cordoned his house and detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted bottles of liquor were found at his house cum hotel. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 03(three) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of available witnesses. The whole process of seizure has been made in between 19.45hrs to 20.25hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person namely Goutam Roy (42yrs) S/O Lt Khagendra nath Roy of Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Goutam Roy (42yrs) S/O Lt Khagendra nath Roy of Bartolla Ektiasal Ps Bhaktinagar Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
