(i) One transparent plastic packet containing contraband seems to be Brown Sugar, Weighing approx 57(Fiftyseven) grams.

(ii) One black coloured leather type bag.

I, PSI Chiranjit Saha S/O Madhab Saha of Khalpara TOP-II under Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 01(one) arrested accused person namely Kailash Sahani (50) S/O Lt. Sarikan Sahani of Simria Bhindi, P.O- Hayaghat, P.S- Kalyanpur, Dist.-Samastipur(Bihar) A/P Tikiya Para near Fish Market, Ward No. 28, P.O-Siliguri Bazar, P.S- Siliguri, Dist.-Darjeeling to the effect that today i.e on 20.03.2024 at about 18.15 hrs received a specific source information that 01 (one) person was standing at Dangipara near Rail gate under Khalpara TOP-II, PS- Siliguri, Dist.-Darjeeling with huge quantity of Brown Sugar for selling the same to his designed customers. Accordingly, the matter was diarized in General diary vide Khalpara TOP-II GDE No 525 dated 20.03.2024 and subsequently informed the matter to O/C Khalpara TOP-II and being directed, myself along with SI Newton Biswas, ASI Injamamul Hoque and C/706 Tapan Debnath all of Khalpara TOP-II under Siliguri P.S, SPC left for Dangipara near rail gate under Khalpara TOP-II, PS- Siliguri, Dist.- Darjeeling by Govt. Vehicle driven by CD/ 1703 Suchandan Saha along with investigation kit to verify the veracity of the information in hand vide Khalpara TOP GDE No 526 dated 20.03.2024 and M.C.C. No. 325 dated 20.03.2024. I also informed professional videographer namely Tapan Mandal (34) S/O Tushata Mandal of Surya Sen Colony, Block-E, W/No. 34, P.S-NJP, Dist.- Jalpaiguri to come at Dangipara near Rail gate under Khalpara TOP-II, PS- Siliguri, Dist.-Darjeeling for videography of search and seizure. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Dangipara near Rail gate under Khalpara TOP-II, PS- Siliguri, SPC, I contacted two persons namely (1) Santosh Das (54) S/O Lt. Pranbandhu Das of 02 number Jyotinagar Colony, W/No.- 04, P.O- Siliguri Bazar, P.S- Siliguri,, Dist.- Darjeeling and (2) Md. Islam (45) S/O Lt. Md. Dayud of Santoshinagar, W/No. 05, P.O- Siliguri Bazar, P.S-Siliguri, Dist.- Darjeeling and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses noted above reached at Dangipara near rail gate under PS Siliguri, Dist.- Darjeeling at 18.45 hrs and being pointed by the source approached towards 01 (one )person standing at Dangipara near Rail gate under Khalpara TOP-II, P.S- Siliguri. At that time seeing the police party approaching towards him, he started to fled away from the spot but however we managed to apprehended him. Thereafter, we disclosed our identity and inform him regarding the information in hand and stated him that he will be searched in person for the said purpose.

Accordingly, at 19.10 hrs. Shri Moksedur Rahaman, WBPS, ACP, ICP Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day arrived at the spot at Dangipara near Railgate under PS- Siliguri, Dist.- Darjeeling as Special Executive Magistrate, SPC. Then, I offered the independent witnesses and the accused persons to search our police party as per provision of law but they did not search the police party. After that in presence Shri Moksedur Rahaman, WBPS, ACP, ICP Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day and 02 (two) independent witnesses, I searched the detained person namely Kailash Sahani (50) S/O Lt. Sarikan Sahani of Simria Bhindi, P.O- Hayaghat, P.S- Kalyanpur, Dist.- Samastipur (Bihar) A/P Tikiya Para near Fish Market, Ward No. 28, P.O-Siliguri Bazar, P.S- Siliguri, Dist.- Darjeeling following all formalities, keeping his decency and recovered (i) One transparent plastic packet containing contraband seems to be Brown Sugar, Weighing approx 57(Fifty-seven) grams (ii) One black colored leather type bag. Further, on demand in presence of Shri Moksedur Rahaman, WBPS, ACP, ICP Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses the above noted detained persons failed to produce any valid documents in support of possessing of Brown Sugar found from his possession.

Being further interrogation, the accused person noted above admitted in presence of Shri Moksedur Rahaman, WBPS, ACP, ICP Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day and the independent witnesses that he has procured the above noted Brown Sugar clandestinely for the purpose of selling the same in high rate to his designed customers for his personal gain by illegal means. He also disclosed that he has been dealing in this business of procuring and selling of Brwon Sugar illegally for last few months for his wrongful gain.

Thereafter, I weighted recovered 01 (one) packet containing said to be Brown Sugar in presence of Shri Moksedur Rahaman, WBPS, ACP, ICP Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day and the independent witnesses with the weighing instrument and found total 57 (fifty-seven) Grams of said to be brown sugar which was kept inside the black colored leather type bag.

Accordingly, I seized the above noted articles from the exclusive possession of the above noted accused person at the spot at Dangipara near Rail gate under PS Siliguri, Dist. - Darjeeling under proper seizure list in presence of Shri Moksedur Rahaman, WBPS, ACP, ICP Fulbari, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, of SPC for the day as well as independent witnesses as noted above.
