Sir,

In producing herewith one arrested accused person namely Sanjit Mandal @ Sonu (M/30 Yrs), S/O- Late Baidyanath Mandal, resident of Gossainpur, Notun Para, PS- Bagdogra, Dist- Darjeeling (not verified) along with the following seized articles under proper seizure list:

1. One iron made improvised firearms with one active hammer & trigger measuring 24 cm in total length including 14 cm single barrel, 14 cm butt, marked as Exhibit-A loaded with one live ammunition measuring 7.8 cm in length with active percussion cap found marked K4 63 7 on the percussion cap, marked as Exhibit-B.

I, SI Samik Paul of Bagdogra PS, SPC do hereby lodge this written complaint against the above noted arrested accused person Sanjit Mandal @ Sonu to the effect that today on 20.03.24 at 16:05 hrs received secret source information that one person is waiting beside NH-2 near Uttora entrance gate at Gossainpur area to sell a firearms to his designed customer for his wrongful gain. Accordingly, I appraised the matter to O/C Bagdogra PS and diarized the matter in GD vide Bagdogra PS GDE No. 995 dated 20.03.24. Then as per direction of O/C Bagdogra PS, I formed a team with C/1509 Sourav Roy Sarkar, VP/02 Pradip Roy & CV/389 Janak Singh and left for Gossainpur area vide MCC No. 604/24 dated 20.03.24. This refers to Bagdogra PS GDE No. 996 dated 20.03.24. Our source accompanied us. At around 16:20 hrs we reached near Uttora entrance gate at Gossainpur and contacted with two local witnesses there namely (i) Tapas Kumar Barman (M/38), S/O- Late Mahendra Barman, resident of Batlabari, PO & PS- Bagdogra, Dist- Darjeeling; Supervisor, Security Guard, Uttora and (ii) Utpal Goswami (M/45), S/O- Late Ajoy Goswami, resident of Gossainpur, Rupsingjote, PS- Bagdogra, Dist- Darjeeling. The witnesses accompanied us. At around 16:35 hrs our source identified the suspect. Accordingly, as per identification and indication by source, we managed to apprehend one person beside NH-2 near Uttora entrance gate at Gossainpur and searched him. On search, one iron made improvised firearms loaded with one live ammunition is found from his possession kept concealed on his right side of waist under the shirt and we recovered the same. The live ammunition is unloaded from the firearms for safety reason. Then we interrogated him. On interrogation he revealed his identity as Sanjit Mandal @ Sonu (M/30 Yrs), S/O- Late Baidyanath Mandal, resident of Gossainpur, Notun Para, PS- Bagdogra, Dist- Darjeeling and disclosed that he had been waiting there to sell the firearms to his designed customer. On demand he failed to produce any valid license/document for possessing & carrying illegal firearms. Subsequently, I seized the firearms loaded with live ammunition under proper seizure list and labeled the same in presence of independent witnesses. At last, I arrested the accused person Sanjit Mandal @ Sonu (as noted above) for possessing and carrying illegal firearms after telling him the ground of arrest and issued memo of arrest in this regard. The process of search, seizure & arrest was done on 20.03.2024 in between 16:35 hrs & 17:45 hrs.

Therefore, I request you to initiate a specific case under proper section of law against the above noted arrested accused Sanjit Mandal @ Sonu (M/30 Yrs), S/O- Late Baidyanath Mandal, resident of Gossainpur, Notun Para, PS- Bagdogra, Dist- Darjeeling and arrange for its investigation.
