Respected Sir,

I Rukshat Khatoon, Wife of Md. Hasan Raza, Daughter of Md. Afroz Khan, resident of Adarsh Nagar Colony, Ward No. 04 S.M.C., Government Saw Mill Road, P.O. Siliguri Bazaar, P.S. Siliguri, Dist: Darjeeling beg to state as follows:

1. That my marriage was arranged with one Md. Hasan Raza Son of Alam Khan who is a residence of Gondria, Khavtola, P.O. Panasi, P.S. Paharkatta, Dist: Kishanganj(Bihar) on 18/10/2022 according to Muslim Rites and customs. The said marriage was arranged by a broker namely Ibrahim Khan who is a resident of Kalakachu, Islampur.
2. That in the marriage the bride groom and his family demanded huge dowry from my family which included Rs. 1,50,000/- and one latest motorcycle(bike). Apart from this my parents gave one bed with bedding, blanket and pillows, one godrej sofa set, alna, showcase, dressing table, dining table, tea table with 4chair, trunk, fridge, mixer grinder, steel and fiber dinners et, brass utensils, 5set suit, 4 set saree, 6pc thali, dastari, 6pc spoon, tea set, pressure cooker 2pc, fibre plate 6pc, bowl set, cup set, bed sheet 6pc, mat, steel jug, steel serving tray, steel bucket, iron, 6pc parda, kadhai 2pc, cooking utensils etc.
3. That huge amount of gold and silver were also given including dastana 60gm(silver), Payal 100gm, Tike 5gm(gold), Bangles 120gm(silver), Choti 120gm(silver), Necklace 150gm(silver), earring 5gm(gold), Ring 2.5gms (/gold), ring 5gm(gold) etc.

That after my marriage on 18/10/2022 I reached my in laws house at the above mentioned address on 19/10/2022 where on I got a surprising welcome from my in laws and my sister in laws, where they said "Your parents did not spend anything in your marriage, you came from very low standard family having no social prestige at all , we are unfortunate that we arranged our son's marriage in such a family" I somehow managed to bear and tolerate the shock of such a horrifying "welcome" to my in-law house.

5. That since the day of my marriage my husband namely Md Hasan Raza, did not talk to me or did not even share the room with me. He would be out of the house day and night. Later I came to know that he use to stay with a girl namely Pooja day and night and would make video calls on whatsapp and would show me off with that girl. On asking him as to why he is doing such a thing he would simply say that he has no heart and feelings for me and is in love with that girl.

6. That my in laws namely Alam Khan(Father in law), Asghari Khatun(mother in law), Salma Khtoon (Sister in law), Jubair Khan(Brother in law) started torture on me on daily basis. They would not provide me any food and proper medicines for my treatment. My said sister in law namely Salma Khatoon along with her husband snatched away all my gold and silver jewellery.

7. That on 18/12/2022 my said husband left me at my maternal house stating that he would come to pick me up after few days. After reaching there I tried contacting my husband on daily basis to which he would not respond at all and would simply disconnect it. Later I came to know through other sources that he was already married and had a son of 6months old. That he married me with an intention of grabbing huge sum of dowry from me and after taking away the entire dowry they would either kill me or disown me.

8. That last week on 07/03/2024 my father had a heated argument with my said husband where he told that he would come back to take me with proper arrangements and would also keep me in good and healthy environment. That today i.e. 18/03/2024 my said husband came along with his entire family and forcefully entered my house and on reaching instantly started assaulting me with fists and blows. That my said mother in law pulled me by my hair locke and dragged me out of the room. That my said husband even tried to strangulate me

with the dupatta that I was wearing. They started to assault me and abused me with filthy languages and started to threaten me that in case I lodge any complain they would kill me and my family. They also stated that they will never ever take me back under any circumstances and will also not give back my things that were given during marriage. Later I got myself treated at Siliguri District Hospital.

That all the above named persons are fraud and criminal minded and got their son married to me with the intention to grab huge sum of dowry from my parents and then later to disown me. I kindly request you to take instant action against the aforesaid culprits.
