

L ASI Dhruba Mishra of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Anil Sarkar (56yrs) S/O Lt. Kesto Sarkar of Purba Dhantala, Sattelite Township PS New Jalpaiguri Dist.- Jalpaiguri under arrest along with following seized articles;

- 1. Twenty one (21) sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
- 2. Fifteen (15) bottles of India made liquor Kachi 70 up , each bottle 300 ml, Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1.

I am submitting a written complaint against the above noted accused person to the effect that on 19.03.24 at 22-15 hrs received source information that one person was selling Liquor illegally from his house at Purba Dhantala , Sattelite Township under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith C/1462 Sajan Tamang, CV-306 Biswajit Roy, CV-297 Putul Roy all of NJP PS, SPC left for South Colony to verify the veracity of information vide NJP PS GDE No. 1007 Dated- 19.03.24. On arrival at the spot at 22-45 hrs it was found that one person mentioned above was selling liquor illegally from his house to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally from his house Purba Dhantala, Sattelite Township without any license. Thereafter in presence of witnesses I recovered (1) Twenty one (21) sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml and (2) Fifteen (15) bottles of India made liquor Kachi 70 up, each bottle 300 ml from his possession from his shop and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 23-05 hrs to 23-35 (seizure Total approx 15.3 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Anil Sarkar (56yrs) S/O Lt. Kesto Sarkar of Purba Dhantala, Sattellte Township PS New Jalpaiguri Dist.-Jalpaiguri and arrange for its investigation.
