I, Smt. Pampa Saha, Wife of Sri Sanjib Saha, resident of 1 No. Dabgram Colony, Gokhel Road, Rabindra Sarani, P.O - Rabindra Sarani, P.S - Siliguri, District - Darjeeling, West Bengal - 734006, I am writing to bring to your attention that that I am the owner of one motor car being one white SWIFT DZIRE VDI bearing registration number WB74AP1333, Chassis No. MA3FJEB1S00A61816, Engine No.D13A2995007. Yesterday, i.e., on 21.03.2024 at around 10.030 a.m. my driver namely Sri. Asis Sarkar, son of Late Anil Sarkar took my vehicle from the garage of my residence and left with the vehicle to for servicing of the said vehicle. Thereafter, when he did not report back I asked my brother in law Sri. Sujit Saha, Son of Late Radheshyam Saha, to call the driver about his whereabouts. When my brother in law called him to ask him about his whereabouts he did not respond to his calls thereafter he switched off his cellphone bearing number (7679666389). Thereafter, we tried to search him in his rented accommodation at Ashighar Colony, near Pragati Sangha Club, P.O Ghoghomali, P.S Ashighar, District- Jalpaiguri, with the help of his friends but he was not traceable there. Later, his friends informed that his permanent address is situated at Gidaler, Pailasanjur, Kathalerabari, Majumder Sarkar Para, Near Jhajhangi Hotel, Khagadabari-2, Maynaguri, P.S.- Maynaguri, District- Jalpaiguri, PIN- 735224. Today, I sent my brother in law to search for him at his permanent address at Maynaguri and my brother in law talked with the family members of the said driver Sri. Asis Sarkar and he was shocked and surprised to discover from his mother and



Smt. Renu Sarkar, that Sri. Asis Sarkar had visited his home along with the vehicle at Maynaguri at the night of 21.03.2024 and stayed there entire night. That his mother also informed that he was in an intoxicated state when he came home with the vehicle and after spending the entire night in the house he left with the vehicle early in the morning without giving any intimation to his mother. (Renu Sarkar- 9679795308). Hence, the vehicle still remains in the illegal possession of said Sri Asis Sarkar since 21.03.2024 and the said act amounts to theft. I have a reasonable apprehension that he may misappropriate the same for his illegal gain and profit.

I therefore request you to take appropriate measures against the said culprit namely Sri. Asis Sarkar, son of Late Anil Sarkar, presently residing at Ashighar Colony, near Pragati Sangha Club, P.O Ghoghomali, P.S Ashighar, District- Jalpaiguri, permanent resident of Gidaler, Pailasanjur, Kathalerabari, Majumder Sarkar Para, Near Jhajhangi Hotel, Khagadabari-2, Maynaguri, P.S.- Maynaguri, District- Jalpaiguri, PIN- 735224. Contact no. 7679666389 and book him under appropriate measures of law.
