Sir,

I, **SRI TAPAN DUTTA**, S/O Late Dulal Kanti Dutta, resident of Defence Colony, Lane No. 6, Upper Bagdogra, P.O. & P.S. Bagdogra, Dist. Darjeeling, (W.B), do hereby lodge this written complaint to the effect that Aman Dutta (since deceased) was/is my son who was facing some personal health issues while he was in Chennai and accordingly he returned back home on 16/03/2024 by flight and on reaching Bagdogra he was complaining about some rashes in his body. On the same day I took my said son to Neotia Getwel Multispecialty Hospital, City Centre, Matigara in order to get proper treatment in a reputed Hospital. My son was admitted in General ward under the observation of Dr. Najuma Subba, Dermatologist (skin). It is to mention here that said Dr. Najuma Subba was not present on that particular date i.e. on 16/03/2024 but make diagnosis for the patient through video conferencing with other doctors.

On the next day i.e. on 17/03/2024 when my son was feeling unbearable pain in his body, I asked the attending doctors about such condition of the patient, they told me that Dr. Najuma Subba is on leave and will join the Hospital on 18/03/2024 and thereafter will see the patient. On 18/03/2024 when said Dr. Najuma Subba came to Hospital and found that my son was suffering from Chickenpox and was in serious condition. Then only I came to know that my son was actually suffering from chickenpox and kept in the Hospital without any proper treatment for chickenpox for two days. On 18/03/2024 at about 8.30 PM when the condition of my son deteriorated gradually he was shifted to ventilation by said doctor.

During ventilation also the doctors did not allow me to see my son or said anything about the progress of the patient. At 11.45 PM when we found the doctors and attendants are not giving any satisfactory response to us, we doubted something wrong had happened to my son and thereafter entered the ventilation room forcefully and found that my son was not responding and the screen of the monitor was showing NIL. On asking the doctors told us that my son Aman Dutta is now no more.

We all were astonished to hear the news from the doctors. Thereafter at about 2.30 AM a meeting was conducted in the conference room of the hospital where the doctors of the hospital namely Dr. Asif Iqbal Hussain, MD, Dr. Kalyan Lahiri, MD, Dr. N.K. Singh, Neurologist, Dr. Malyashree Roy, Anesthesia and the patient party including myself were present wherein I asked the doctors that my son travelled alone all the way from Chennai to Bagdogra, he also came to hospital on foot and was admitted in the hospital with healthy body in general bed then how can he die within three days of his admission? The doctors have no answer to my question. They started defending themselves by making false excuses.

Sir, there exists CCTV Cameras in the meeting room from where you can search out the entire recording of the conversation between the doctor's team and the patient party.

My son was 19 years old boy. He was admitted in the hospital and kept for three days but was not given any sort of treatment for chickenpox. Doctors' detected chickenpox on the third day of his admission i.e. on 18/03/2024 and prior to that he was kept under the management of general physician and was diagnosed virtually by Dr. Najuma Subba. It is a gross negligent on the part of doctors whom we believe as next to God who can save life. I still fail to understand why such deliberate carelessness cropped up in the treatment of my son.

I do not have any words to describe this pathetic incident as I have lost my son who was just 19 years of age due to the negligent and irresponsible act of the doctors of Neotia Getwel Multispecialty Hospital.

The hospital authorities were also denying to handover the body of my son to me. My son has medi-claim policy in his name but the hospital authorities took one blank cheque from me as a security and thereafter only hospital authorities handed over the dead body of my son to me.

Sir, my son was not provided with any sort of treatment since his admission in the aforesaid hospital. My son would not die if he was given proper treatment of chickenpox from the very first day of his admission in the hospital. The Hospital management may provide alternate skin doctor in absence of Dr. Najuma Subba who was on leave on 16/03/2024 & 17/03/2024 but they did not do so rather they waited for Dr. Najuma Subba to come as a result of which I lost my son.

It is also to mention here that a team of doctors of Neotia Getwel Multispecialty Hospital are involved in this awful act namely **Dr. Najuma Subba**, Dermatologist, **Dr. Asif Iqbal Hussain**, MD, **Dr. Kalyan Lahiri**, MD, **Dr. N.K. Singh**, Neurologist, **Dr. Malyashree Roy**, Anesthesia, **Dr. Ranjan Das**, BCRM 44610 and **Dr. Asis Kumar Das**, Medical Superintendent; all the doctors named above are responsible for the death of my son Aman Dutta. I hereby enclose the Death Report of my said son issued by the concerned Neotia Getwel Multispecialty Hospital for your kind perusal.

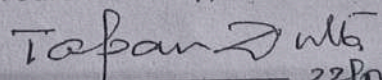
I, therefore, request you to take immediate legal action against all the above named doctors and management of Neotia Getwel Multispecialty Hospital considering the circumstances herein before stated. The delay in lodging of this F.I.R may kindly be condoned as I was engaged in the cremation work and also mentally depressed after the sudden demise of my young son.
