Sir,

With due respect, I am producing herewith 01 (one) arrested accused person named Uday Sha (55), S/o- Ganga Sha of Tulshi Nagar, Kholaiboktari, PS- Matigara, Dist- Darjeeling under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 11 (eleven) bottles of Himalayan Gold Country Spirit 60 UP (each bottle containing 600 ml and 6.6 ltrs in total).

I, PSI Avijit Banik, presently attached with Matigara PS, SPC under your kind control beg to state that on 24.03.24 during Holi special mobile van duty vide MTG PS GDE No. 1399, Dated- 24.03.24, at about 18.55 hrs, I received a secret source information that one person as noted above is selling ID liquor illegally from his shop located at Tulshi Nagar, Kholaiboktari, PS- Matigara, Dist- Darjeeling. Accordingly, I inform the matter to you and as per your kind direction, myself along with C/868 Sujal Roy, C/523 Sanjit Kundu all of Matigara PS, SPC left PS for Tulshi Nagar, Kholaiboktari under Matigara PS to work out the information in hand. At about 19.10 hrs we arrived at Tulshi Nagar, Kholaiboktari in the shop of the above noted arrested person and as per indication by the source, I apprehended the above noted person in red hand who was selling ID liquor from his shop. On being asked he disclosed his name and address as noted above. During raid, the persons who were buying liquor were able to flee away from the shop of the accused person. During interrogation he disclosed that he is selling ID liquor from his shop located at Tulshi Nagar, Kholaiboktari, PS- Matigara, Dist- Darjeeling for his illegal gain. On being search his shop, the above noted I/D liquor were recovered. On demand he failed to produce any documents/license in respect of store/sale of the I/D liquor which were recovered from his shop. Accordingly, I seized the above noted I/D liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure, label & arrest was made in between 19.20 hrs to 19.55 hrs on 24.03.2024.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused named Uday Sha (55), S/o- Ganga Sha of Tulshi Nagar, Kholaiboktari, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
