26/03/2024 at around 3pm in the afternoon, I and
my friends along with my neighbours and their
kids were celebrating Holi and were at my
above mentioned address. Four persons on a bike
came on a bike vide no - (WB 79-A 3676)
outside our house with a bucket of a colour
water and poured it on my two daughters.
I along with my neighbours were there and we
saw it and kept shouting and eventually we
stopped it and told them to go away as we will
call police. my children were trembling with fear.
After about half an hour again the same persons
along with their other friends came on with a still
bucket of water from a drain and tried pouring it
on my daughters.
While I rushed to save
my daughters, these persons kept shouting
Holi Holi on top of their voice and put colour
on my daughters.

Our neighbours come to our rescue but they kept assaulting and ~~beating~~ constantly kept abusing me and my daughters. When my Uncle br. Krishu Kamakar intervened to aid us. They intentionally ran over his feet with their bike.

One of my relatives who was also present then i.e. Pratap Kamakar and his son also tried to stop them assaulting us by Abhijit Bhoosh took a still bucket and hit Pratap Kamakar's son with it on his chest. In the meantime other people gathered and these persons ran away by threatening me that they will kill me and attack my daughters with Acid whenever they see us.

All these persons ran away keeping their vehicle outside our house and my neighbours also called the police who took away the vehicle later.

I fear for the safety of my children and my self and hence this Complaint.
