- 1: That I am the law abiding citizen of India, and a permanent resident of aforesaid address.
- 2. That I am a reputed business man.
- 3. That the said SUBHO SAHA, S/O Bablu Saha, resident Narmada Bagan More, Near water Supply Tank, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjecling is known to me since long.
- 4. That subsequently the said SUBHO SAHA, S/O Bablu Saha, being my friend approached me to become a business partner in my business.
- 5. That thereafter I upon the approached of the said SUBHO SAHA, S/O Bablu Saha, had put certain terms and conditions for running my business with the said Subho Saha, S/O Bablu Saha on a partnership firm.
- 6. That thereafter the said SUBHO SAHA, S/O Bablu Saha, refuse to agree upon those terms and conditions and I upon his refusal the proposal of the said SUBHO SAHA, S/O Bablu Saha, to become my partner into my business.
- 7. That subsequently on 04.03.2024 the said SUBHO SAHA, S/O Bablu Saha, and from his registered mobile whatsapp number 9641799028 send some vulgar messages as well some use slang words and also started to call me repetitively and threatened me to destroy my business and also the goodwill of my business in the Market.
- 8. That after that when I ignored to receive his calls then the said SUBHO SAHA, S/O Bablu Saha, started to call me through several numbers nos. 6396256631/8906715882 sending some threatening and vulgar messages and also spreading false rumburs against me to my business colleagues and also my clients.

- That the said the said **Subio Saha**, S/O Bablu Saha are extorting money from me for an amount Rs. 10,00,000/- (Rupees Ten Lakh) only and also blackmailing that if I fail to them the demanded amount of Rs. 10,00,000/- (Rupees Ten Lakh) only or if I try to lodge any written complaint against them then they will kill me and my family members and will also destroy my business.
- 10. That finding no other alternative I have lodged a written complaint before the Officer-in-charge Khalpara TOP against said SUBHO SAHA, and after enquiry the concern P.S. was started specific case against the above named accused Person, vide Khalpara P.S. Case No. 265 of 2024 under section 447,385,34 of I.P.C. and subsequently one of the above named accused person BABLU SAHA was arrested and produced before the Ld. A.C.J.M. Court, at Siliguri on 24.03.2024 and subsequently one of the accused person Ld. Court enlarged the accused person on interim bail.
- 11. That after release the Bablu Saha becomes furious and stated to threatening me that if I do not withdraw the instant case against the above named accused person then the above named accused person will abduct me and my family members.
- 12. That after that on 26.03.2024 at about 9:30 p.m. when I returned my home through Burdwan Road, near Shivam Place, suddenly two persons on their Activa Scooty, one of who was SUBHO SAHA, blocked my way and started to abuse me in filthy languages and threatened that if I do not withdraw the instant case then they will abduct me and will kill me
- persons i.e., **SUBHO SAHA**, S/O Bablu Saha along with another anti social, started to beat me with fist and blows, continuously beating me and snatch my silver chain from my neck and when I tried to protest then the said advantage started to beat me mercilessly on my head and other body parts the place
- 14. That subsequently I called my family members with the help of local people who rescued me and on the next day I went to the nearby Paramount Hospital. (Copy of Medical document annexed herewith)
- 15. That the said BABLU SAHA in connivance with SUBHO SAHA, S/O Bablu Saha are very vindictive in nature and they are continuously threatening me his grant of bail and also the Ld. Court order.

16. That I am a helpless person and seeking justice from you by taking necessary legal action against the culprit, namely the said SUBHO SAHA, S/O Bablu Saha, and BABLU SAHA to take the necessary legal steps as my life is in danger and the above named accused person can any time attack me at any place.
