Sir,

In producing herewith one arrested accused person namely Tapan Sarkar (40) S/O Lt. Niranjan Sarkar of Sukanta Nagar near Alok Sangha Club, ward no. 38, PO- Rabindranagar, PS- Bhaktinagar, Dist.- Jalpaiguri along with the following articles under proper seizure list: -

- (i) 20 (Twenty) sealed bottles of "Scotch Malts TUBORG Premium Strong Classic beer" each bottle containing 650 ml ( $650 \times 20 = 13000$  ml) and each bottle MRP Rs- 140/= Total value Rs. 2800/- and marked as "Exhibit-A" out of which 01 (One) bottle has been taken as sample and marked as "Exhibit -A-1".
- (ii) 12 (Twelve) sealed bottles of "COPENHAGEN TUBORG Premium Strong beer" each bottle containing 650 ml ( $650 \times 12 = 7800$  ml) and each bottle MRP Rs- 135/= Total value Rs. 1620/- and marked as "Exhibit-B" out of which 01 (One) bottle has been taken as sample and marked as "Exhibit -B-1".
- (iii) 12 (Twelve) sealed bottles of "HAYWARDS 5000 Premium Strong beer" each bottle containing 650 ml ( $650 \times 12 = 7800$  ml) and each bottle MRP Rs- 125/= Total value Rs. 1500/- and marked as "Exhibit-C" out of which 01 (One) bottle has been taken as sample and marked as "Exhibit -C-1".

1. ASI Prasenjit Barman S/O Lt. Sarat Chandra Barman of Ashighar Out Post, Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Tapan Sarkar (40) S/O Lt. Niranjani Sarkar of Sukanta Nagar near Alok Sangha Club, ward no. 38, PO- Rabindranagar, PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 02/04/2024 at 20:30 hrs. I received a source information that above noted arrested accused person has stored a huge quantity of illegal liquor at his residence and is selling the same in his residence at Sukanta Nagar without any valid license to his customers for his illegal gain. Accordingly, the fact is diarized in the General Diary vide Ashighar Out Post GDE No 60, Dated 02/04/2024, and shared the information with O/C Ashighar Out Post. Subsequently, as per kind direction of OC Out Post, I along with the force had been to Sukanta Nagar under Bhaktinagar P.S. Dist.- Jalpaiguri to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of the above-noted accused and managed to apprehend him. On being asked he disclosed his identity as noted above and admitted that he was selling illicit liquor at his residence without any license for his wrongful gain. On search the above noted seized articles were recovered from his residence which was kept concealed under his living bed. On demand, he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Thereafter, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the above-mentioned person namely Tapan Sarkar after observing all sorts of formalities on the spot. The whole process of seizure and label has been made in between 21:25 hrs. to 22:50 hrs.
