In producing herewith, one accused person named Belal Md. (21) S/o Lt. Najrul Hoque of vill- Sitaguri, P.O- Bhutkihat, PS- Bhorer Alo, Dist- Jalpaiguri along with following seized articles under proper seizure.

- 1 One improvised one shooter small fire arms with iron butt measuring 30 cm (approx) in length from its barrel to butt having one striking pin, striking hammer and trigger in working condition.
- 2 Two round live ammunitions.

I, ASI Sanjay Saha of Bhorer Alo PS do hereby lodge this written complaint against the above noted accused person named Belal Md. (21) S/o Lt. Najrul Hoque of vill- Sitaguri, P.O- Bhutkihat, PS- Bhorer Alo, Dist- Jalpaiguri to the effect that on 26.03.24 at 2205 hrs during my night van duty received a source information that one person is moving suspicious at 18 No. Milanpally near Apanjon Hotel under Bhorer Alo PS with fire arms in his procession for some illegal purpose. Accordingly, I share the information with O/C PS and being instructed by O/C PS myself along with C/1507 Somen Ghosh, C/1517 Biswanath Barman left for 18 No. Milanpally near Apanjon Hotel along with kit box.

On way to 18 milanpally I contacted two persons namely 1) Debu Mandal ( 32) S/O Sudhir Mandal of 18 No. Milanpally, PS Bhorer Alo, Dist- Jalpaiguri and 2) Dilip Mandal (35) S/O Lt. Amulya Mandal of 18 No. Milanpally, PS Bhorer Alo, Dist- Jalpaiguri and make them aware of the information in hand and requested them to act as witness if any search and seizure would be made necessary upon which they agreed. Subsequently, I along with force and the independent witnesses further proceeded for 18 No. Milanpally near Apanjon hotel.

At 22.25 hrs we reached at 18 No. Milanpally near Apanjon Hotel and I contacted my source and subsequently being pointed by the source found one person was moving suspiciously and heading towards Apanjon Hotel. Seeing his movement there was reason to believe that he possesses a suspicious article with him. On seeing the police persons, he tried to flee away from the spot. We then chased him and could be able to apprehend him. On interrogation, he disclosed his identities as noted above. Subsequently, I searched his possession in presence of the independent witnesses and recovered one improvised one-shooter small fire arms with iron butt which was kept at his left side waist underneath the T-shirt and also found two rounds of live ammunitions which were kept inside the right side pocket of his jeans pant. Subsequently, being asked, he failed to produce any documents in support of his possession of said firearm and ammunitions, but he failed to produce any valid documents to possess the said arms and ammunition.

On further interrogation, he disclosed that he had procured the said illegal arms and ammunition clandestinely for selling to his designed customer of Milanpally area for his personal gain. Then I seized the above noted arms and ammunitions from his conscious and exclusive possession and labeled the same. The whole process of search, seized and label was made in between 22.45 hrs to 23.25 hrs. Subsequently, I arrested the accused person named Belal Md. (21), S/o Lt. Najrul Hoque of Vill- Sitaguri, P.O- Bhutkihat, PS- Bhorer Alo, Dist- Jalpaiguri after informing the ground of arrest and observing all formalities.

In this circumstance, I pray your good office that a specific case may kindly be initiated against the above noted accused person named Belal Md. (21) S/o Lt. Najrul Hoque of vill- Sitaguri, P.O- Bhutkihat, PS- Bhorer Alo, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
