Respected Sir,

I, SMT SUSHMITA TAMANG, Wife of Subash Tamang, aged about 34 years, permanent resident of Salbari, Shiv Gram Lane No 1. P.O Salbari, P.S Pradhan Nagar, Siliguri, Dist Darjeeling, in the state of West Bengal would beg to state as follows:-

That SMT SARU GURUNG, W/o Umang Gurung, and her husband both resident of Saipath, Parijat Road, Methibari, P.O Salbari, P.S Pradhan Nagar, Siliguri, Dist Darjeeling became acquainted with me after her husband had constructed a residential building at Methibari P.O Salbari, P.S Pradhan Nagar, Siliguri, Dist Darjeeling.

That the said Saru Gurung and her husband had gradually built up a friendly relation with me over a period of time and had accordingly convinced me to lend them intrest free loan as the said Saru Gurung and her family was going through financial troubles and she had faced huge losses in her business, she further promised me to return the said interest free loan within a short period of time and believing upon her promises and assurances firstly I lended her an amount of Rs 2,00,000/- (Rupees Two Lakhs) Only in the year 2021.

That sir after that she frequently used to visit me and had convinced me to lend her more money every time and she had also promised me to return the entire amount even by selling her husband house located at Salbari, Methibari incase her business of retail gold jewelries does not recover from losses she stated that her business is in Nepal and the house at Salbari, Methibari is her husband's house, but every time Saru Gurung failed to live up to her promises and had miserably failed to repay me a single penny which she had secured from me over her fake promises and assurances.

It is pertinent to mention here that I on the other had in order to help her had even pledged my and my family's jewelries with the local jewelers.

That in the month of January 2024 as I was badly in debt, I pressurized her to return the amount which she secured from me over a period of time upon her never fulfilled fake promises, she asked me to make an agreement and record in writing that she would repay me the entire money amounting to Rs 20,00,000/-(Rupees Twenty Lakhs) within a period of five months and had further issued me cheques to discharge her liability.

That sir I had presented the said cheque for clearance but was returned unpaid from the bank with remarks insufficient balance and I have been trying to reach Saru Gurung but after visiting her house at Salbari Methibari I came to know from her in-laws, that she has in the similar manner cheated many peoples from Darjeeling and its surrounding areas and now she is trying to go to Israel.

That sir her in-Laws have also informed me that Saru Gurung is hiding in Nepal with her relatives.

Therefore Sir, I request you to kindly register my complaint and take necessary action against Saru Gurung as she has cheated me for the total amount of Rs 20,00,000/- (Rupees Twenty Lakhs) and she is trying to permanently escape from India.
