In producing herewith one arrested accused person namely Kanai Hela (44 yrs), s/o – Lt. Ram Singh Hela of Lala Lajpat Roy road, Ashram Para, Horijon Busty, W/No- 14, PS-Siliguri, Dist - Darjeeling along with seized articles (1) 10 (Ten) sealed Bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml. when packed, MRP Rs. 155/- each (2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1.

I, PSI Prakash Chandra Sarkar of Panitanki TOP under Siliguri PS herby lodge this written complaint against the above noted accused person to the effect that on 22.04.2024 at 17.45 hrs received secret source information that one person is carrying huge quantity of country spirit bottle through Sevoke Road, near M-Bazar, towards Horijon Busty. Accordingly informed to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 572, dated 22.04.2024 and thereafter as per his direction I along with, ASI Surajit Mallick, C/899 Somnath Roy left from Panitanki TOP to work out the information. On arrival at Sevoke Road, near M-bazar, Siliguri at 18.05 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sale the same to the local public of Horijon Busty, Ashram Para under Siliguri PS adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 10 (Ten) sealed Bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml. when packed, MRP Rs. 155/- each (2) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made in between 18:30 hrs to 18:45 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. Total value of seized articles is Rs.1550/-.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Kanai Hela (44 yrs), s/o – Lt. Ram Singh Hela of Lala Lajpat Roy road, Ashram Para, Horijon Busty, W/No- 14, PS- Siliguri, Dist - Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
