I, Smt. Neeta Biswakarma Wife of Pukar Biswakarma, residing at Prakash Nagar, Chiharujote, Ward No. 42, S.M.C, P.O.- Salugara, P.S.-Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my husband, Pukar Biswakarma Son of Late Tikaram Biswakarma residing at Prakash Nagar, Chiharujote, Ward No. 42, S.M.C, P.O.- Salugara, P.S.- Bhaktinagar, Dist. Jalpaiguri, Mansova Biswakarma (mother-in-law) wife of Late Tikaram Biswakarma, Prakriti Biswa (Sister-in-law) Wife of Kamal Biswa , Bishal Biswakarma (Brother-in-law) Son of Late Tikaram Biswakarma, Jiwan Biswakarma (brother-in-law) son of Late Tikaram Biswakarma residing at Sakham forest busty, Gorubathan, P.O. Fagu, P.S. Gorubathan, Dist- Kalimpong, Bina Biswakarma @ Bina Dudraj (Sister-in-law) wife of Pradeep Biswakarma @ Pradeep Dudraj and Pradeep Biswakarma @ Pradeep Dudraj Son of not known residing at Ganesh Dara, Darjeeling, P.O. & P.S. Darjeeling Bazar, Dist. Darjeeling to the effects as follows:-

- 1. That my marriage was solemnized on 04-05-2009 along with Pukar Biswakarma at Malbazar Kali Mandir after that I went to my matrimonial house at of Sakham forest busty, Gorubathan, P.O. Fagu, P.S. Gorubathan, Dist- Kalimpong.
- 2. That after marriage my husband start to work as a truck driver in Siliguri and we along with my mother-in-law started living in a rented house at Prakash Nagar, Ward No. 42, S.M.C, P.O.- Salugara, P.S.- Bhaktinagar, Dist. Jalpaiguri.
- 3. That out of the said wedlock I gave birth to one female baby namely Yasti Biswakarma on 19-06-2012.
- 4. That after the birth of female child my husband started to come home late night and in drunken condition and used to assault me and my minor daughter mercilessly with fists, blows and kicks and taunting me saying "why I gave birth to a girl/female child", he always used to disrespect me and not used to come home for many days and not even used to feed me and my daughter properly.
- 5. That my mother- in-law with the abetment of my other-in-laws regularly abused me in obscene, abusive and filthy languages and ridicules and yell at me as to why-I gave birth to a girl child why not a boy child have been committing mental and physical torture upon me and threatening me to quit and vacate home or to face dire consequences.
- 6. That I have been tolerating all the above cruelty and inhuman behavior from my husband, mother-in-law and other-in-laws, emotionally, physically and mentally abuses and assaults committing upon me by the aforesaid in- laws but I did not lodge any complaint against them in any authority in the hope and expectations

that one day they will understand me and shall change their attitude and behavior towards me but all went in vain.

- 7. That after tolerating all the torture and inhuman nature of my husband and my in-laws, I again conceived a baby, during pregnancy period my husband and in laws used to threaten me that if I will not do abortion or drop the upcoming child then he will not live with me at any cost, and my husband and in laws left rented home and did not came back, after fighting all the odds I gave birth to a boy child on 30/10/2021 namely "Mohit Biswakarma", all the medical expenses for both of my son and daughter was provided by my brother-in-law, and my sister.
- 8. That after giving birth to my son my husband, mother-in-law and my other-in laws came to visit me at rented house at Prakash Nagar, Ward No. 42, S.M.C, P.O.- Salugara, P.S.- Bhaktinagar, Dist. Jalpaiguri, and threatened me that they will kill me and my two children and my husband will live peacefully with another women namely Divya Chhetri and Geeta Singha. My husband also have illicit relationship with different women.
- That my brother-in-law namely Jiwan Biswakarma called me on my cell phone and abuses in filthy languages and threatened to drive me out my matrimonial home.
- 10. That on 18/04/2024 I asked my husband about his such illicit relation after hearing he became furious and started assaulting me mercilessly anyhow I saved myself from his clutches. On the very same day I rushed to Siliguri District Hospital and treated my injuries in that hospital.
- 11. That all my original documents Aadhaar Card, Voter Id, Pan Card, Cast Certificate, Ration Card of mine and my daughter, Birth Certificate of mine and my 2 children, Bank Passbook, Post Office Passbook of my Daughter, are under the custody of my husband, and you are requested to recover the said documents from the custody of my husband. When I asked him politely to give me back my documents he denied and started to yell and shout at me in loud voice and said he will not give/ return back my documents to me.

So, therefore, I humbly request your goodself to take stringent legal action against them and booked the aforesaid persons as per the provision of law at an earliest.

I shall ever remain grateful for the needful and be obliged thereby.
