Respected Sir,

I Rahmat Husain, Son of Late. Isarail, resident of Lower Bhanu Nagar, Near Children Park, Ward no. 43, P.O. Sevoke Road, P.S. Bhakti Nagar, Dist:- Jalpaiguri, begs to state as follows:-

1. That my son namely Shoaib Akhtar along with one Sk. Tushif Raza, Son of Md. Maksood Alam, resident of same as mentioned above, who is our neighbor as well as a friend of my son, ~~yesterday~~ <sup>on</sup> i.e. 17/04/2024 at around 08:00 P.M. my son along with his above mentioned friend went eat some snacks opp. to Sachitra Hotel situated at Sevoke Road and after buying the snacks from the nearby shop they were sitting on a scooty and eating which was parked nearby.
2. That around 8:30 P.M. to 9:00 P.M. while they were seated on the scooty a vehicle (4 Wheeler/ Car) having registration Number **WB 74 AB 3929** was coming at a very high speed and was driving very rashly and negligently and hit the scooty on which my son along with his friend was sitting beside the road after which my son received multiple injuries on the head/brain and multiple stitches on neck and chest and was taken to Anandalok Hospital and seeing the situation he was transferred to ICU his friend also received several injuries and is also in the same hospital.
3. That my son is currently battling with death and it is very much uncertain whether my son will survive this fatal accident caused by the rash and negligent driving of the above mentioned vehicle.
4. That I could not lodge the F. I. R. in the due time as me and my entire family were not mentally stable and were in a state of shock and fear seeing the critical condition of my son.

I therefore request you to kindly take strict action against the said vehicle driver/owner for the ends of justice.
