With due respect, I, Sri Santosh Roy, son of Late Rajendra Roy, resident of Thiknikata, P.O. Susrata Nagar, P.S.- Matigara, Dist.- Darjeeling, constituted attorney of the Sri Harendranath Roy, S/o Late Ramen Singh Roy, do hereby inform you that one Harendranath Roy owner of the land measuring about 0.11 Acres recorded in R.S. Khatian No. 2/8 corresponding to L.R. Khatian No. 166, R.S. Plot No. 176/192 corresponding to L.R. Plot No. 422 within Mouza Kawakhari, J.L. No. 72, Touzi No. 91, Pargana- Patharghata, P.S.- Matigara, Dist.- Darjeeling, in the State of West Bengal have filed a Title Suit being No. 71/2024 on 22.04.2024 in the Court of The Ld.
