Respected Sir,

I Sri Sudip Seal. Son of Late Sunil Chandra Seal, resident of 1-No. Dabgram. Near Electric Supply Office, P.O. Rabindra Sarani, P.S. Siliguri, District- Darjeeling, would like to inform you that on 03.03.2024 at about 6.00 am when I was on my morning walk, from Dabgram to Saudangi Ashram, near Sarada More in the house of Shyamal Roy, about 500 meter away from my house, I noticed that some boys were playing loud music in the house of the Shyamal Roy where a marriage ceremony was held, and hearing the loud music in the morning I stopped in front of that house to look at it. Then I noticed some boys in the drunken condition asked me intentionally where I was going, I ignored them and moved on. Then suddenly some unknown persons called me who were present in the house of Shyamal Roy and stopped me from going.

Thereafter I asked them the reason of stopping me and suddenly without any reason they started to hit me and assaulted me with fist and blows and throwing me on the road. And they also choked my throat and tried to kill me.

It is also pertinent to mention here that I was carrying my phone. Rs. 1000/- in the phone cover and I was also wearing a gold chain. They have snatched and took away everything that I had with me. Then they left me in abounded condition. And I was not in a condition to move as I was hurt. Then after sometime I managed myself to go the hospital and do the primary treatment. I am late in submitting this complaint as I was out of Siliguri.

Thus I request you to take necessary steps and action against the persons who were present at Shyamal Roy house during marriage as per law of the land.
