Sir,

I Smt. Manu Krishna, Wife Of Kunal Kumar, Editor In Chief of **"THE NEWS BOX"**, Resident of Hill Cart Road, Ward No. 6, Siliguri Municipal Corporation, P.S & P.O Siliguri, Dist. Darjeeling. Would Like to Inform You about an incident that took place on 30<sup>th</sup> April, 2024 at Panpati Area Ward No. 8, Siliguri Municipal Corporation.

That on 30<sup>th</sup> April, 2024 the State GST Department with their Forces had conducted an Official Raid in the premises of Sri. Chironji Lal and Roshan Lal who were the sole proprietor of Pan masala In Panpati Area, Ward No. 8. Whereupon after such notification I went there to take the coverage of the aforesaid Raid with my Team. Whereas when I went there certain person obstructed in the entrance of the premises and when my Camera man started taking Coverage of such Raid one person who was witnessing the Raid came and obstructed my camera man to take the Coverage by using his hand he blocked the lens of the camera so that my camera man could not take the video of such incident.

Following to such obstruction it is painful to mention that another man who was also present there came in front of me and started abusing me which are slanderous upon my resistance to such act he tightly hold my wrist and pushed me back and touched me inappropriately along with the person who obstructed the camera man from taking coverage and threatened me and my cameraman of facing dire consequences if ever in future we enter into their premises.

Therefore, it is kind request to you to trace out those persons and to take stringent action against such persons under the relevant provisions of laws.
