Would Like to Inform You about an incident that took place on 30th April, 2024 at Panpati Area Ward No. 8, Siliguri Municipal Corporation.

That on 30th April, 2024 the State GST Department with their Forces had conducted an Official Raid in the premises of Sri. Chironji lal and Roshan lal who were the sole proprietor of Pan masala In Panpati Area, Ward No. 8.
