In producing herewith one accused person named Md Samim (21yrs) S/O Lt Md Sahimuddin of Ashrafnagar ward no 40, PO Anchal, PS Bhaktinagar, Dist Jalpaiguri under arrest along with following seized articles under proper seizure.viz

One white color toto (E-Rikshaw) without number plate containing one multi colour nylon bag, the bag contained 11 (eleven) bottles Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml, Rs 155/- each and 15 (fifteen) litters of illicit liquor locally called as chullu.

With due respect and humble submission, I SI Youel lepcha S/O Jai tshering lepcha of Bhaktinagar PS under Siliguri Police Commissionerate would like to lodge this written complaint against above noted Md Samim (21yrs) S/O Lt Md Sahimuddin of Ashrafnagar ward no 40, PO Anchal, PS Bhaktinagar, Dist Jalpaiguri, to the effect that today on 05.05.2024 at about 18.10hrs i received a source information that one person is possessing illegal liquor at the back side of Payal cinema hall under Bhaktinagar PS without any valid license.

Accordingly I informed the matter to the I/C PS and as per his kind direction I along with ASI Chandra Prakashj Adhgikary, ASI Dipak Karmakar, C/374 Debraj Biswas had been to the back side of Payal cinema hall under Bhaktinagar PS to verify the veracity of source information. At 18.35hrs we reached there and being identified by source, I along with my force cordoned the area and able to detain the above noted person with his toto (E-Rickshaw). Subsequently on being asked the apprehended person disclosed his name and identity as noted above and recovered One white color toto (E-Rikshaw) without number plate containing one multi colour nylon bag, the bag contained 11 (eleven) bottles Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml, Rs 155/- each and 15 (fifteen) litters of illicit liquor locally called as chullu. On demand he failed to produce any valid license/papers for possessing such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain.

Therefore I seized the above mentioned illegal illicit liquor and his toto (E-Rickshaw) under proper seizure list in presence of witnesses and arrested the above mentioned person at the back side of Payal cinema hall under proper memo of arrest after observing all sorts of formalities at the spot. The whole process of seizure was made in between 19.05hrs to 19.25hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Md Samim (21yrs) S/O Lt Md Sahimuddin of Ashrafnagar ward no 40, PO Anchal, PS Bhaktinagar, Dist Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
