In producing herewith following four accused namely 1) Banti Sahani (19yrs) S/O Barun Sahani of Prakash nagar sahani Busty PS Bhaktinagar, Dist Jalpaiguri, 2) Pobitra Barman (18yrs) S/O Lt Shiren Barman of Vivekananda Nagar, Near Health Centre, PS Bhaktinagar Dist Japaiguri, 3) Bishnu Barman (19yrs) S/O Lt Subash Barman of Saluagar Vivekananda Nagar Near Health Centre, PS Bhaktinagar Dist Jalpaiguri, 4) Jeeban Boro (30yrs) S/O Hanok Boro of Kumripata Panitanki, PS Baksha, Dist Nalbari Assam (Not verified), A/P Salugara near Reliance Mall PS Bhakinagar, Dist Jalpaiguri, 5) Ajoy Sahani (23yrs) S/O Lt Hari Chand Sahani of Prakash nagar sahani Busty ward no 43 PS Bhaktinagar, Dist Jalpaiguri with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) measuring 18 inches recovered from the conscious possession of Banti Sahani
- 2) One iron made 'Knife' and rope recovered from the Conscious possession of Pobitra Barman.
- 3) One iron made weapon called as 'Bhojali' 14 inches recovered from the conscious possession of Bishnu Barman.
- 4) One iron rod measuring 38 inches recovered from the exclusive and conscious possession of Jeeban Boro
- 5) One small knife and torch light recovered from the exclusive and conscious possession of Ajoy Sahani.
- 6) One navy blue color Toto (E-Rickshaw)

I, ASI Dipak Karmakar S/O Lt Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 1) Banti Sahani (19yrs) S/O Barun Sahani of Prakash nagar sahani Busty PS Bhaktinagar, Dist Jalpaiguri, 2) Pobitra Barman (18yrs) S/O Lt Shiren Barman of Vivekananda Nagar, Near Health Centre, PS Bhaktinagar Dist Japaiguri, 3) Bishnu Barman (19yrs) S/O Lt Subash Barman of Saluagar Vivekananda Nagar Near Health Centre, PS Bhaktinagar Dist Jalpaiguri, 4) Jeeban Boro (30yrs) S/O Hanok Boro of Kumripata Panitanki, PS Baksha, Dist Nalbari Assam (Not verified), A/P Salugara near Reliance Mall PS Bhakinagar, Dist Jalpaiguri, 5) Ajoy Sahani (23yrs) S/O Lt Hari Chand Sahani of Prakash nagar sahani Busty ward no 43 PS Bhaktinagar, Dist Jalpaiguri and 6/7 others to the effect that on 08/05/2024 at 00:05 hrs received a specific source information that 11/12 miscreants have assembled at Gandhi maidan near mohan weighing bridge under Bhakti Nagar PS, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Bhanu nagar under Bhaktinagar PS.

Accordingly, I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 404/24, dated 08.05.2024 and as per order I along with SI Rantu Haldar, SI Youel lepcha, ASI Chandra Prakash Adhkari, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for maidan near mohan weighing bridge under Bhakti Nagar PS to work out the information in hand. At about 00.15 hrs we arrived at maidan near mohan weighing bridge under Bhakti Nagar PS as indicated by the source we noticed that 11/12 persons assembled at maidan near mohan weighing bridge under Bhakti Nagar PS and

they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party somehow managed to apprehended above noted 05 (five) of them with deadly weapons but 6/7 persons managed to fled away from the spot taking the advantage of darkness and open place.

On being asked they could not produced the document of said toto (E-Rickshaw) and on interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that the following persons namely Bittu, Prem, Sapan, Sayan and others were present there and making preparation for committing dacoity at Bhanunagar under Bhaktinagar PS. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted toto (E rikshaw) and weapon of offence from their exclusive and conscious possession under proper seizure list duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 08/05/2024 in between 01.05hrs and 01.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely 1) Banti Sahani (19yrs) S/O Barun Sahani of Prakash nagar sahani Busty PS Bhaktinagar, Dist Jalpaiguri, 2) Pobitra Barman (18yrs) S/O It Shiren Barman of Vivekananda Nagar, Near Health Centre, PS Bhaktinagar Dist Japaiguri, 3) Bishnu Barman (19yrs) S/O It Subash Barman of Saluagar Vivekananda Nagar Near Health Centre, PS Bhaktinagar Dist Jalpaiguri, 4) Jeeban Boro (30yrs) S/O Hanok Boro of Kumripata Panitanki, PS Baksha, Dist Nalbari Assam (Not verified), A/P Salugara near Reliance Mall PS Bhakinagar, Dist Jalpaiguri, 5) Ajoy Sahani (23yrs) S/O It Hari Chand Sahani of Prakash nagar sahani Busty ward no 43 PS Bhaktinagar, Dist Jalpaiguri, Bittu, Prem, Swapan, Sayan and others kindly arrange for its investigation.
