Under the aforesaid circumstances; I on behalf of the NCR Atleos, request your good self to take necessary action. So that we can provide our services to the public at large.

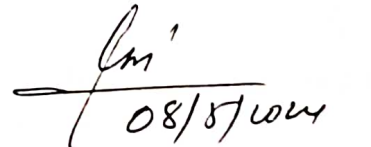
