Respected Sir,

With due respect and humble submission I Sailesh Subba of Ambari Out Post under Bhorer Alo PS,SPC want to apprise you that on 08.05.2024 when I was deputed to perform Night Table Duty at Ambari Police Out Post under Bhorer Alo P.S, Siliguri Police Commissionerate from 22.00 hrs to 08.00 hrs, At that time I took the GD Charge from S.I Kamal Biswas on 08.05.2024 at 22.05 hrs.

On 09.05.2024 at 00.25 hours S.I Prabodh Chandra Das of Bhorer Alo P.S/SPC came at Ambari O.P along with three accused persons viz: (i) Raja Sharma (32) s/o Late Tulshi Sharma of Ratanlal Basty, Ward No. 01, PO+PS Pradhan Nagar, Dist. Darjeeling (not verified) (ii) Md. Chottu (30) s/o late Md. Anwar of Mallaguri, Ratanlal Basty, Ward No. 01, PO+PS Pradhan Nagar, Dist. Darjeeling (not verified) (iii) Mastan Mamun (27) s/o Masaraf Hossain of Samsia Telipar, PS Kushmandi, Dist. Dakshin Dinajpur, At present residing behind Durga mandir, Kadamtala, PS Matigara, Dist. Darjeeling (not verified) who were arrested in c/w Bhorer Alo P.S Case no. 81/24 Dated 08.05.2024 u/s 21(c) of NDPS Act 1985 came at O.P and kept them in O.P's hazat for safe custody vide Ambari/Falakata O.P GDE No. 258, Date. 09.05.2024.

On 09.05.2024 at 01.05 hrs, everything was going normal and I was busy in writing GD, but suddenly I heard noises coming out from the OP's Hazat. Accordingly, I along with one civic volunteer CV-01 Jaychand Roy went out to check whether the accused persons are living normal or not inside the Hazat. However, it was discovered that one accused Raja Sharma was standing near the gate of Hazat and another accused person Mastan Mamun was breaking the Hazat's concrete brick wall by scratching the wall with the help of water tap and made a big hole near Hazat's toilet in order to escape from the Police Custody. After seeing us, the accused Mastan Mamun immediately stopped his work. I then immediately rush behind the room of the hazat and restrained the accused persons from coming outside. I along with CV-01 Jaychand Roy sought for help and accordingly the available Officers who were present in Police Barrack came at Out Post and opened the lock of the hazat and apprehended all the three accused persons noted above and kept them under-strict vigilance. Further on interrogation all the above noted accused persons confessed and disclosed that they had made a plan to break the wall of the Hazat by carving with the help of toilet tap which they had broke out to escape from the hazat. I informed the matter to Superior Officer and as per their direction I prepared seizure list and seized 1] One (01) piece of iron made water tap 2] Five (05) pieces of red color wall bricks. 3] Some amount of sand extracted during carving of wall from the Hazat. The matter is diarized at Ambari/Falakata OP vide GDE No. 259, Date.09.05.2024. Further as per direction of Superior Officer all the three accused persons were sent to New Jalpaiguri Police station and kept there for safe custody.

Under the above circumstance, I pray before you that a specific case may kindly be initiated against the accused persons namely (i) Raja Sharma (32) s/o Late Tulshi Sharma of Ratanlal Basty, Ward No. 01, PO+PS Pradhan Nagar, Dist. Darjeeling (not verified) (ii) Md. Chottu (30) s/o late Md. Anwar of Mallaguri, Ratanlal Basty, Ward No. 01, PO+PS Pradhan Nagar, Dist. Darjeeling (not verified) (iii) Mastan Mamun (27) s/o Masaraf Hossain of Samsia Telipar, PS Kushmandi, Dist. Dakshin Dinajpur, At present residing behind Durga mandir, Kadamtala, PS Matigara, Dist. Darjeeling (not verified) under proper section of law and arrange for its investigation.
