With reference to the above numbered complaint as lodged by me on 02.05,2024, it is stated that the said Naresh Chandra Barman is still continuing with the illegal construction over the LR Plot No. 3 and has not stopped his construction activities. Rather, he being an advocate, is doing all such illegal activities knowing fully aware the order passed by the Hon'ble Court on 19.03.2021 in CO No. 8 of 2021 and also the order passed on 10.01.2024 in WPA No. 568 of 2021 read with WPA No. 1725 of 2021 followed by the order dated 21.03.2024 2021 followed by the order dated: 21.03.2024 passed in MAT No. 16 of 2024 and MAT No. 18 of 2024. He had/has no regards for the law of the land. It is stated that he is continuing with his construction even after the intimation given by the police authorities, since after lodging the above complaint.

Sir, yesterday on 12.05.2024, when I visited the site, I found that he has put the rolling shutter in the said illegally constructed premises and also put one sign board of his hotel /restaurant business. It is to be mentioned here that he had/has been doing the said hotel/restaurant business in another premises, which had/has also illegally constructed in nearby/attached LR Plot No. 6 and against which, the dismantling order has been passed by Panchayat pursuant to the order dated: 10.01.2024 passed by the Hon'ble Court read with further order passed on 21.03.2024 by the Hon'ble Division

And as such I therefore, request you to take a note of the above development in the above case record and do the needful to punish the culprits.
