**Sub: Written complaint**

Respected Sir/Madam,

I, SMT. BINDU AGARWAL, Wife of Sri Gopal Agarwal, Daughter of Late Satish Kumar Garg, residing at the house of Sunil Rakshit (Rakshit Bhawan), Opposite Sunrise Club, Lake Town, P.S. Siliguri-734007, Dist-Darjeeling, would like to inform and request you as follows:

That I got married to one Sri Gopal Agarwal, son of Sri Rajendra Kumar Agarwal, resident of G1, Sidhi Vatika II, Burdwan Road, P.O. & P.S. Siliguri, District - Darjeeling on 18<sup>th</sup> June, 1999 at Rishi Bhawan, Burdwan Road, Siliguri and after our marriage I started residing with my in-laws at G1, Sidhi Vatika II, Burdwan Road, P.O. & P.S. Siliguri, District - Darjeeling and I continued to reside there. Out of our wedlock we have one daughter, namely, Garima Agarwal (aged about 24) and one son namely, Ayush Agarwal (aged about 22 years). Since past 8 years of our marriage we have some matrimonial disputes between us and my husband as well as my in-laws started torturing me mentally and physically. After 11 years of our marriage I came to know that my husband is having an affair with a woman namely, Mrs. Anju Agarwal, Wife of Shyam Agarwal, Resident of Shaktigarh, near Laddu Gopal Sweet Shop, Siliguri.

That in the month of April, 2023 the amount of torture upon me arose in extreme level and my father-in-law through me out from my matrimonial house. After that with no other option left my daughter and I left my matrimonial house. Then I along with my daughter took shelter in a rented house. My daughter stayed with me for some days and after some days she left me and started residing with her father in my matrimonial house. That since then I residing alone in my rented house. That I don't have any fan in my rented house and recently due to increase of the temperature I called my mother-in-law for providing me a cooler. After that my mother-in-law send me a cooler through my son which is not working properly and when I told my mother-in-law that the cooler is not functioning properly, she told me that I'm not worthy of

anything and that she told me to return the cooler to her. So on 15.05.2024 I went to my matrimonial house to return the cooler to my mother-in-law. Then suddenly she started accusing me and abusing me with filthy languages and when I tried to save myself my husband started beating me with fist and slap me. That after that I immediately need to go for medical help and went to Siliguri District Hospital. That since a long time I have been facing immense torture and pain and all my endurances have failed and I am in fear that my in-laws and my husband can go to any extent to torture me and harm me and my life.

You are, therefore, requested to kindly take immediate and necessary action against above-named persons.
