I, **Smt. Lakshmi Saha W/o Sri Subrata Saha**, Resident of Abhoy & Co, Nehru Road, Khalpara, Siliguri, P.O. & P.S. Siliguri, Dist- Darjeeling., do hereby lodge this written complaint to the effect that:-

1. That my husband is the Co-owner of the land measuring 6 kathas along with 3(three) storied building thereon in Plot No . 2840/ 3760 , recorded in Kathian no. 281/1 of Mouza- Siliguri , J.L. No. 11(88), Ward No. IX of Siliguri Municipal Corporation, Pargana- Baikunthapur , Holding No. 39/36/359/318, Police station- Siliguri, District- Darjeeling, and in the said land rampant illegal construction is being done by **Smt. Dipali Saha W/o Lt. Raimohan Saha & Sri. Khokan Saha, Sri Debabarata Saha and Smt. Pampa Roy** all are sons and daughter of Lt. Rai Mohan Saha.
2. That my husband is the Co-owner of another adjacent plot of land measuring 6 kathas along with 3(three) storied building thereon in Plot No . 2840/ 3760 , recorded in Kathian no. 281/1 of Mouza- Siliguri , J.L. No. 11(88), Ward No. IX of Siliguri Municipal Corporation, Pargana- Baikunthapur , Holding No. 39/36/359/318, Police station- Siliguri, District- Darjeeling, and in the said land rampant illegal construction is being done by **Sri. Khokan Saha & Sri Debabarata Saha** both are sons of Lt. Rai Mohan Saha.
3. That the above mentioned plots of lands a **Stop Work Notice** has been issued by the Siliguri Municipal Corporation and the **Honorable Calcutta High Court , Circuit Bench at Jalpaiguri** , vide **WPA/190/2024**, order dated **01.2.2024** (attached herewith) have also acknowledged the same and have instructed/ ordered to **Stop** such illegal and unauthorized construction and Subsequently vide **WPA 856 of 2024 and WPA 857 of 2024** , order dated **01.05. 2024** has been ordered by the **Honorable Calcutta High Court , Circuit Bench at Jalpaiguri** "to not carry any further construction in the building in question and there shall be status quo as regards the nature, character and possession of the said property". Despite such orders of the **Honorable Calcutta High Court , Circuit Bench at Jalpaiguri** , vide **WPA/190/2024**, order dated **01.2.2024** (attached herewith) and **WPA**
