With due regards, I, SMT. SUSHMITA SARKAR. Wife of Sri Rabi Banik, Daughter of Sri Bijay Sarkar, residing at JISHU ASHRAM (Lenin Colony), Jitu, Marigara, District Darjeeling, would like to lodge this written complaint to the effect that:-

My mother Smt Archana Sarkar, having enjoying peacefully a piece and parcel of land measuring 1 Katha, situated at JISHU ASHRAM (Lenin Colony), Jitu, Matigara, District Darjeeling from last 15 years accordingly. It is to be mentioned here that on 17.05.2024. near about 11 A.M. said 1) SMT CHAMPA RAY, Wife of Sri Mantu Ray, 2) SRI MANTU RAY, Son of Sri Babulal Ray, 3) ELA GHOSH, Daughter of Sri Dhreen Ghosh, 4) SMT MEENA GHOSH, Wife of Sri Mahadev Ghosh, 5) SMT DIPTI EKKA, Wife of Sri Lajarush Ekka, all are the residing at JISHU ASHRAM (Lenin Colony), Jitu, Matigara, District Darjeeling, are criminal trespass of my mother above said land and throw out the pucca pillars from the said land and when I along with my mother raised objection against their such type of illegal acts they did not bother to assault me physically and also abused me with filthy and abusive languages. They also assault my mother mercilessly and broken my mother mobile. In the mean time when I raised objection of their said illegal acts they became more aggressive towards me and became furious and assaulted me on my head, back, ear and also on my private parts and threatened me with dire consequences and abuse me with filthy and offensive languages not only that said Mantu Ray has been assault or criminal force me and pulls my clothes with intent to outrage my modesty and said Mantu Ray take advantage of the situation and snatch my gold chain from my neck and when I raised objection on their said illegal acts and shouting then they fled way from the place. And they also threatened me at the time of leave the place that if my mother did not handover the said land to their hands then they will not hesitate to ruin my mother life.

That Sir, Sri Mantu Ray & Others thus committed an offence Acts done by several persons in furtherance of common intension, Criminal trespass, Voluntarily causing grievous hurt, Wrongful restraint, Theft, Assault or Criminal force to women with intent to outrage her modesty, Criminal intimidation, Word, gesture or act intended to insult the modesty of a women.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against them as per the provision of law and obliged thereby. Thanking you
