

Sir,

In producing herewith following four accused namely i) Rahul Hossain (M/21yrs) S/O-Nazrul Mia of Samar nagar, Battala, PO- Champasari, P.S- Pradhan nagar, Dist- Darjeeling, ii) Shyam Kr Paswan (M/25yrs) S/O- Lt Ashok Paswan of Limbu busty, near Maszid, w/n - 42 PO Salugara, PS- Bhaktinagar Dist- Jalpaiguri, iii) Haren Das (M/19yrs) S/O- Ranjit Das of Aamtala, Bottle company, W.No-41, PO- Sevoke road, PS- Bhaktinagar Dist- Jalpaiguri, iv) Abhi Das (19yrs) S/O - Goutam Das of Chota Fapri, PO- Salugara, PS- Bhaktinagar Dist- Jalpaiguri with following seized articles viz:

1) One iron made sharp cutting knife and one iron rod measuring 16 inches recovered from the exclusive and conscious possession of Rahul Hossain.

2) One iron rod measuring 18 inches and one torch light recovered from the exclusive and Conscious possession of Shyam Kr Paswan.

3) One iron made knife **#** from the exclusive and conscious possession of Haren Das.

4) One small torch light and iron rod approx 12 inches recovered from the exclusive and conscious possession of Abhi Das.

I, SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Rahul Hossain (M/21yrs) S/O- Nazrul Mia of Samar nagar, Battala, PO- Champasari, P.S- Pradhan nagar, Dist- Darjeeling, ii) Shyam Kr Paswan (M/25yrs) S/O- Lt Ashok Paswan of Limbu busty, near Maszid, w/n - 42 PO Salugara, PS- Bhaktinagar Dist- Jalpaiguri, iii) Haren Das (M/19yrs) S/O- Ranjit Das of Aamtala, Bottle company, W.No-41, PO- Sevoke road, PS-Bhaktinagar Dist- Jalpaiguri, iv) Abhi Das (19yrs) S/O - Goutam Das of Chota Fapri, PO-Salugara, PS- Bhaktinagar Dist- Jalpaiguri and 6/7 others to the effect that today on 31.05.2024 at 00:15 hrs received a specific source information that 10/12 miscreants have assembled at Dumping Ground, Baikunthapur under Bhakti Nagar PS, Dist.- Jalpaiguri with deadly weapons and making preparation for committing dacoity at Bhakti nagar PS area. Accordingly, I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 1703/24 dated 31.05.2024 and as per order I along with ASI Dipak Karmakar, ASI Chandra Prakash Adhkari, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for Dumping Ground, Baikunthapur under Bhakti Nagar PS, Dist.- Jalpaiguri to work out the information in hand. At about 00.35 hrs we arrived at Dumping Ground, Baikunthapur under Bhakti Nagar PS, Dist.- Jalpaiguri as indicated by the source we noticed, that 10/12 persons assembled at Dumping Ground, Baikunthapur under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police police and started to flee away from the spot but we the police party after a hot chase managed to apprehended 04 (four) of them with deadly weapons in their possession but 6/7 persons managed to fled away from the spot taking the advantage of darkness and open place.

SI Romtu Hallar 04-31/05/29 On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that the following Rahul Mandal, Chandan Sahani, Amar Adhikary and others were present there and making preparation for committing dacoity at under Bhakti Nagar PS area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them at Bhakti Nagar PS. The search seizure and arrest made on 31/05/2024 in between 01.15hrs and 02.25 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons and others namely i) Rahul Hossain (M/21yrs) S/O- Nazrul Mia of Samar nagar, Battala, PO- Champasari, P.S- Pradhan nagar, Dist- Darjeeling, ii) Shyam Kr Paswan (M/25yrs) S/O- Lt Ashok Paswan of Limbu busty, near Maszid, w/n - 42 PO Salugara, PS- Bhaktinagar Dist- Jalpaiguri, iii) Haren Das (M/19yrs) S/O- Ranjit Das of Aamtala, Bottle company, W.No-41, PO- Sevoke road, PS- Bhaktinagar Dist- Jalpaiguri, iv) Abhi Das (19yrs) S/O - Goutam Das of Chota Fapri, PO- Salugara, PS- Bhaktinagar Dist- Jalpaiguri, v) Rahul Mandal vi) Chandan Sahani, vii) Amar Adhikary, and others kindly arrange for its investigation
