at about 06:00 hrs, in the morning, my

Fatapukur, P.S.-Rajgarj, Distt.-Jalpaiguri
came from his native place from Bihar by
Bus & got down at Near Vegetable Market

the road there to catch the Bus for Fatu-
Pukur at that time suddenly a truck
bearing Regd. No. WB-76-B-2890, coming
from Naulkhal direction, came in a high
speed and driven by a unknown driver in
