Sir,

In producing herewith three (03) accused persons namely (i) Shibu Paul (24), S/O Lt. Budhadeb Paul of South Ambedkar Colony, 01, PS. Pradhan Nagar, Dist. Darjeeling, (ii) Md. Faruk (22), S/O Md. Abdul Gaffar of Salbari, Naya Busty, PS. Pradhan Nagar, Dist. Darjeeling, (iii) Md. Budha (22), S/O Md. Sk. Hafizuddin of Ratanlal Busty, W/No. 01, PS. Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure:-

One iron made sharp weapon locally called as "Khukuri" measuring 18 inch (i) (approx) in length including its wooden butt recovered and seized from the possession of accused Shibu Paul,

One iron made sharp cutting weapon locally called as "Khukuri" measuring (ii) approx 18 inch in length including wooden butt recovered and seized from

the possession of accused MD. Faruk,

One iron made sharp knife measuring approx 10 inches in length recovered (iii) and seized from the possession of accused Md. Budha.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted three (03) arrested accused persons and their 04/05 unknown associates who involve in this crime to the effect that on 31.05.24 night at 00.15 hrs received a specific source information that about 07/08 persons assembled at Mahananda River Bed, near Hanuman Mandir, Rajendra Nagar under PS-Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and preparation for committing dacoity at Gurung Busty and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1624 dated 31.05.24. As per your kind order and direction, I accompany with ASI Biplab Kr. Das, C/1411 Ashok Roy, C/1413 Sujit Sarkar, and C/1119 Tamnoy Roy all of Pradhan Nagar PS left for Hanuman Mandir, Rajendra Nagar under Pradhan Nagar PS to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 1625 date 31.05.24. On the way, I informed the matter to night RT van officer ASI Sanjib Mukharjee of Pradhan Nagar PS and directed them to come at Rajendra Nagar near Hanuman Mandir to accompany with us for holding raid at Mahananda River Bed. At about 00.40 hrs we reached at near Near Hanuman Mandir, Rajendra Nagar and after a few time night van officers ASI Sanjib Mukharjee along with force arrived there and accompanied us. Then, I shared the information to all the members of raiding team and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 07/08 persons assembled in a dark place at Mahananda River Bed and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehend above noted three (03) accused persons with deadly weapons in their possessions while 04/05 others managed to flee away from the spot by taking the opportunity of darkness crossing the Mahananda River. On interrogation, they disclosed their identities as noted above. On further interrogation they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Gurung Busty and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.15 hrs to 02.15 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the three (03) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Gurung Busty and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted three (03) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Gurung Busty and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted three (03) arrested accused persons namely (i) Shibu Paul (24), S/O Lt. Budhadeb Paul of SSouth Ambedkar Colony, 01, PS. Pradhan Nagar, Dist. Darjeeling, (ii) Md. Faruk (22), S/O Md. Abdul Gaffar of Salbari, Naya Busty, PS. Pradhan Nagar, Dist. Darjeeling, (iii) Md. Budha (22), S/O Md. Sk. Hafizuddin of Ratanlal Busty, W/No. 01, PS. Pradhan Nagar, Dist. Darjeeling and others 04/05 unknown miscreants and arrange for its investigation.
