

In producing herewith one accused person namely Radha Mohan Roy (52 yrs) S/o Lt. Bhabendra Nath Roy of Dadabhai Colony, Near Military Ghat, W/ No- 43, PS-Bhakti Nagar, Dist- Jalpaiguri along with the following seized articles as per proper

- 1. 10 (Ten) bottles of Himalayan Gold 60 UP country spirit (Each bottle containing
- 2. 10 (Ten) litters of illicit liquor locally called as Chullu.
- 3. One multy colour nylon bag.

I beg to report that I ASI Mukul Basu S/o Bimal Basu of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Radha Mohan Roy (52 yrs) S/o Lt. Bhabendra Nath Roy of Dadabhai Colony, Near Military Ghat, W/ No- 43, PS-Bhakti Nagar, Dist- Jalpaiguri to the effect that on 01/06/24 during my evening van patrolling duty received a source information that one Radha Mohan Roy has gathered huge quantity of illicit liquor at his house at Dadabhai Colony under Bhaktinagar PS for selling to the local customers for his wrongful gain without any valid documents/license. Over this I informed to IC Bhakti Nagar PS. As per your kind instruction myself along with force proceeded to the PO to work out the information. After reaching at his house being identified by the source, our Police party held raid at identified house and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same to the local customers since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 19.45 hrs to 20.10 hrs)

I therefore request you a specific case may kindly be started against the accused namely Radha Mohan Roy (52 yrs) S/o Lt. Bhabendra Nath Roy of Dadabhai Colony, Near Military Ghat, W/ No- 43, PS-Bhakti Nagar, Dist- Jalpaiguri under proper section of law and arrange for investigation.
