I, Richa Rawat aged about 29 yrs, w/o Bhawan Tamang
resident of Maharani Tea Estate, P.O. Tung P.S Kuerseong
Dist Dajepeling would like to inform you that on 14.6.24
at around 11:30 am when we were on the way to
Kholabari, one Swift, black colour car dashed towards my
vehicle, being wagon R grey colour being vehicle No. WB 74 AR-
4735, and started abusing us, we were around five person
in the vehicle including my daughter of seven years, they
were around 5 to 6 persons in that vehicle, they all
came out and damaged my vehicle and came with a
iron rod and bricks and fully destroyed my vehicle and
started hitting us, they pulled my T-shirt and snatched
my gold chain, assaulted my daughter namely Gloria Tamang
and my aunty Sushila Pradhan.

They abused us and threatened us with
dire consequences and we are not feeling safe.

You are requested to kindly look into the
matter at the earliest and take strict action against the
culprits.
