With due respect, I, Shri Jayanta Bhowmik S/O Late B.N. Bhowmik, residing 16, Nazrul Sarani, Ashrampara (Ward no: 14), Siliguri Ward No: 14, P.S: Siliguri Dist: Darjeeling, the Assistant Secretary of Siliguri Ashrampara Agragamee Sangha, am writing to bring a serious matter to your attention that for the development work (for the construction of Indoor Cricket Coaching Center ground at Nazrul Sarani, opposite to Maya Sanyal Nursing Home, we bought a number of Iron rods (16 mm) and staged within our club coaching center ground which is covered by well fenced boundary.

But unfortunately on 14th of June, morning when we went to our club ground and found that 07 ps. of Iron rods (each length is 6 feet) is missing. Our premises is covered by CCTV surveillance and we have seen that around 09.00 pm on 13th June, 2024 some miscreants entered into our coaching center premises and we are sure this is done by that person only.
