Respected Sir,

I, Sri Biplab Sarkar, S/o Late Manindra Nath Sarkar, resident of 17/5, N.L. Bose Sarani, College Para, Ward No. 17, P.O. Siliguri, Dist: Darjeeling Pin Code-734001 wish to inform you that today i.e., on 21st June, 2024 in between 8 to 8.10 pm while I was passing by on my car WB 74 AR 5111 (Baleno grey colour) in Sevoke More Signal, I was badly hit behind my car by three boys on a bike. On telling them that why they did such thing, the boys came down from the bike and seeing them coming towards my car, I locked my car so that they don't create any nuisance. They tried hitting me from the window of my car and punched in the window glass, broke the back light and used filthy slang language on me. As soon as the signal got green, I took the car towards the traffic point, got down from the car and told the traffic police. On telling them, one out of the three persons got caught while the rest two ran away.

It is so shocking that the boys used so abusive words and threatened me that they will kill me and asked me to come near Venus More. I am worried that the other two boys who ran away might harm me or my family as they threatened me.

I would like to know that who were those persons who tried attacking me and also threatened me. I would thus seek your help to get the CCTV footage of the Sevoke more signal and request you to kindly register my F.I.R in the subject matter, for which I shall remain ever obliged.
