With due respect, I, SI Goutam Mallik of Pradhan Nagar Police Station under Siliguri Police Commissionerate producing the herewith the seized articles viz :- (i) one paper made cartoon containing 17 (seventeen) bottles of "KINGFISHER STRONG BEER" each bottle containing 650 ml i,e, total (17 x 650 ml) = 11,050 ml, marked as Exhibit "A" (ii) one paper made cartoon containing 12 (twelve) bottles of XXX old Monk Deluxe Rum each bottle containing 750 ml i,e, total (12 x 750 ml) = 9000 ml, marked as Exhibit "B" and one big size paper made cartoon containing containing 24 (twenty four) bottles of "TUBORG" PREMIUM BEER, each bottle containing 650 ml i,e, total (24 x 650 ml) = 15,600 ml and marked as exhibit "C" out of which 01 (one) bottle of same taken from each cartoon for examination and marked as Exhibit "A1", "B1" and "C1" and would like to lodge this written complaint against one accused namely Sabu Devi Sahani (53 yrs) W/O Upendra Sahani of Sahani Patty, Rajendra Nagar, Coolipara, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 24.06.24 at 00.45 hrs I received a specific source information that one Sabu Devi Sahani of Sahani Patty, Rajendra Nagar, Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling is selling illicit liquor illegally at his residence and she storred huge quantity of illicit liquor at her residence without any valid papers. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No 1232 dated 24.06.24 and informed the matter you. As per your kind order and direction, I along with SI Bandhan Roy, ASI Biplab Kr Das, ASI Monaj Kr Roy, , LASI Mithu Kabiraj, C/1411 Ashok Roy C/1413 Sujit Sarkar, all of Pradhan Nagar PS left for Sahani Patty, Rajendra Nagar, Coolipara under PS- Pradhan Nagar, Dist.- Darjeeling to work out the information. On reaching there and as identified by the source, I along with other officers and force conducted raid at the residence of said Sabu Devi Sahani but found absconding. On search the residence of said Sabu Devi Sahani recovered the above mentioned illicit liquor which were kept conceal under the bed. We search every possible places to find out the owner but found absconding. During enquiry it could be learnt that Sabu Devi Sahani (53 yrs) W/O Upendar Sahani of Sahani Patty, Rajendra Nagar, Coolipara, PS- Pradhan Nagar, Dist.-Darjeeling is running such type of illegal business of selling illicit liquor at her residence without any valid documents for her wrongfull gain. As the said Sabu Devi Sahani willfully violated the norms of Bengal Excise Act, hence I seized the above noted illicit liquor under proper seizure list in presence of witnesses and brough to the PS. The whole process of seizure and label has been made in between 01.10 hrs to 02.05 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against accused Sabu Devi Sahani (53 yrs) W/O Upendra Sahani of Sahani Patty, Rajendra Nagar, Coolipara, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
