In producing herewith three (03) accused persons namely (i) Atikur Rahaman (32 yrs) S/O Imtiajul Haque of Vill- Pokaijote, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Md. Suleman Haque (24 yrs) S/O Samsul Haque of Vill- Anandamoyee colony, Champasari, PS- Pradhan Nagar, Dist.- Drjeeling and (iii) Raju Roy (30 yrs) S/O Surendra Roy of Ratanlal Busty, Mallaguri, PS-Pradhan Nagar, Dist.- Darjeeling under arrest and the following articles under seizure viz :- (i) One iron made sword measuring 30 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Atikur Rahaman, (ii) One iron made sword measuring 28 inch (approx) in length including wooden butt recovered and seized from the possession of accd Md. Suleman and (iii) One iron made breaking instruments locally called as "PLUS" and one sabol measuring 14 inches in length from the possession of accd Raju Roy. I, ASI Biplab Kr. Das of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted three (03) arrested accused persons and their 07/08 unknown associates who involve in this crime to the effect that on 23.06.2024 at 23.55 hrs received a specific source information that about 10/11 persons assembled at Panchanan Nadi near Labanya Kata under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoity at Durgaguri and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1229 dated 23.06.2024. As per your kind order and direction, at about 00.05 hrs. I accompany with ASI Manoj Kr. Roy, C/1169 Prasenjit Barman, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Panchanan Nadi near Labanya Kata under Pradhan Nagar PS to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 1231 date 24.06.2024. On the way, I informed the matter to night RT van officer SI Bhiswadeb Barman of Pradhan Nagar PS and requested him to come at near Panchanan Nadi near Labanya Kata to accompany with us for holding raid at Panchanan Nadi near Labanya Kata under Pradhan Nagar P.S. At about 00.25 hrs we reached at Panchanan Nadi near Labanya Kata and after a while night van officers SI Biswadeb Barman along with RT Van force arrived at Panchanan Nadi near Labanya Kata and accompanied us. Then, I shared the information to all the members of raiding team and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 10/11 persons assembled in a dark place at Panchanan Nadi near Labanya Kata and they were whispering in a very low voice. We cordoned the place from both side with due care and caution. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehened above noted three (03) accused persons with deadly weapons in their possessions while 07/08 others managed to flee away from the spot by crossing Panchanan Nadi taking the opportunity of darkness. On interrogation, they disclosed their identities as noted above. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Durgaguri and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.20 hrs to 02.25 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the three (03) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Durgaguri and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted three (03) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Durgaguri and its surrounding areas.

Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted three (03) arrested accused persons namely (i) Atikur Rahaman (32 yrs) S/O Imtiajul Haque of Vill- Pokaijote, Champasari, PS-Pradhan Nagar, Dist.- Darjeeling (ii) Md. Suleman Haque (24 yrs) S/O Samsul Haque of Vill-Anandamoyee colony, Champasari, PS- Pradhan Nagar, Dist.- Drjeeling and (iii) Raju Roy (30 yrs) S/O Surendra Roy of Ratanlal Busty, Mallaguri, PS- Pradhan Nagar, Dist.- Darjeeling and others 07/08 unknown miscreants and arrange for its investigation.
