Sub:- Complaint Against MD PAPPU (9883272773/ 7557870175), Owner of E-Rikshaw (TOTO) and his Brother-in-law Md. Navin (9144575143).

Respected Sir/ Madam.

With due respect I PANKAJ SHAH, Son of Om Prakash Shah, Resident of Ramkrishna Para, Matigara, P.O. & P.S.- Matigara. District- Darjeeling, West Bengal- 734010 would like to inform you that on 24/06/2024 at around 08:40 pm I met with an accident while stopping at the Red Light (Traffic Signal of City Centre) as I was returning to Matigara (my residence) from Darjeeling More.

Whereas the vehicle was an E-Rikshaw (TOTO) bearing Registration Number- WB 74B 7259 which banged into the rear of my Car (HYUNDAI VERNA 1.6) bearing Registration No.- NL 07H 6005. That after the mishap I pulled over my vehicle and enquired for the reason from the TOTO Driver and also asked him to ring the owner-MD. PAPPU who is a resident of Dangi Para as conveyed by him. Moreover, the owner of the vehicle agreed to negotiate the compensation for the damages incurred to my Vehicle on the next day, i.e. 25/06/2024 and also requested me to kindly park his TOTO in the workshop along with my vehicle. In addition, the Owner of the TOTO (as mentioned above) was aware of the fact since long that his driver abuses Narcotics Substances (LAMA as informed to me by the owner) and this is the reason for parking the TOTO in order to avoid any other mishap that same night.

Whereas on 25/96/2024 the owner of the TOTO informed me that currently he is in North Sikkim and as a mater of fact his Brother-In-Law MD. NAVIN will negotiate on behalf of him in the Workshop (BROTHER'S AUTOMOBILES) situated at Chayan Para behind Bhaktinagar Police Station in the early evening. That MD. NAVIN appeared before the decided time in the early afternoons at the workshop and showed his Hooliganisms in the workshop, slanging, abusing and threating me in the workshop over the call and also threatening the mechanics of the workshop.

I beg to bring to your notice that Md. Navin over the call threatened, abused and intimidated me. In addition, he also captured photographs from his phone of my vehicle parked in the workshop and fled with the TOTO (as mentioned above) mocking me to do whatever I can, in a vulgar tone without negotiating/ paying the compensation for the damages caused to my car due to rash and negligently driving of the TOTO.

I would be thankful if you accept my complaint and kindly look into the matter and do the needful at the earliest possible.
