Presently I am traumatized because the aforesaid persons used to sell LAMA(BROWN SUGAR), Jiban Barman is my elder brother and I protested against him to stop this illegal business for which the aforesaid persons conjointly hatched up a deep rooted conspiracy to kill me.

In view of above you are requested to arrest the aforesaid persons and save me and also stop the illegal business of them to save the society.
